FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, A Levings, or persons acting as his agents (hereinafter referred to as the 'permit holder') of the School of Ecology and Environment, Deakin University, P.O. Box 423, Warrnambool, Vic. 3280 is exempt from section 41 of the Fisheries Act 1982 subject to the conditions specified in Schedule 1, in that the permit holder shall not be guilty of an offence when possessing up to a maximum of 30 king crabs (*Pseudocarcinus gigas*) below the legal minimum length (hereinafter referred to as the 'permitted activity') from the date of this notice until 31 August 1999

SCHEDULE 1

- 1. Any king crabs (*Pseudocarcinus gigas*) taken pursuant to this notice are for research purposes only and must not be sold.
- 2. PIRSA Fisheries and Aquaculture retains the right for a departmental officer or an officer of the South Australian Research and Development Institute to observe the permitted activity at any time.
- 3. All king crabs (*Pseudocarcinus gigas*) taken pursuant to this notice may only be taken by the registered boats *William F Burton* Y073, *Potential* N009, *Soul Commitment* N014 and *Eliza* N040.
- 4. Whilst engaged in the permitted activity the permit holder must have in his possession a copy of this notice and produce a copy of the notice if required by a Fisheries Compliance Officer.
- 5. The permit holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.

- 10. PIRSA Fisheries and Aquaculture retains the right for a departmental officer or an officer the South Australian Research and Development Institute to observe the permitted activity at any time.

- 11. Whilst engaged in the permitted activity the permit holder must have in his possession a copy of this notice and produce a copy of the notice if required by a Fisheries Compliance Officer.
- 12. The permit holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, John Dudura (M122), 18 Elizabeth Street, Streaky Bay, S.A. 5680 (hereinafter referred to as the 'fisher') is exempt from the provisions of Schedule 1, clause 63 of the Fisheries (General) Regulations 1984, subject to the conditions specified in Schedule 1, in that the fisher shall not be guilty of an offence when taking up to 150 razor fish (*Pinna bicolour*) in any one day, from South Australian coastal marine waters from the date of gazettal of this notice until 30 June 2000.

SCHEDULE 1

- 1. All razor fish (Pinna bicolor) taken shall be used for bait only.
- 2. The total number of razor fish (*Pinna bicolor*) taken in any one day, shall be no greater than 150.
- 3. The fisher must include all razor fish (*Pinna bicolor*) taken under this permit on his monthly catch and effort summary provided to the South Australian Research and Development Institute (SARDI).
- 4. The fisher shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.
- 5. Whilst engaged in the collection activity the fisher must have in or about his possession the copy of this notice with which the Director of Fisheries has provided and produce that notice to a PIRSA Fisheries and Aquaculture Compliance Officer forthwith, if and when an officer requests the fisher to produce it. TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Daryl Ormsby (hereinafter referred to as the 'fish farmer'), 3 North Terrace, Penong, S.A. 5690 is exempt from the provisions of section 34 of the Fisheries Act 1982, insofar as the fish farmer may engage in the activities specified in Schedule 1 subject to the conditions specified in Schedule 2 in the waters specified in Schedule 3 from the date of this permit until 30 November 1999.

SCHEDULE 1

The collection of spat of the blue mussel (Mytilus edulis) by the following means: 1 long line spat collector having a maximum length of 100 m.

SCHEDULE 2

- 1. All structures on the site shall be marked in accordance with the Department of Marine and Harbours regulations.
- 2. The fish farmer must maintain records of all collections of spat taken from the approved sites and provide the Director of Fisheries with a written report detailing his collection activitiy at the completion of the permit period.
- 3. The fish farmer shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically permitted by this notice.

- 4. The fish farmer must maintain a copy of this permit which has been supplied by the Director of Fisheries, and if requested by a PIRSA Fisheries and Aquaculture Officer, produce that permit for inspection.
- 5. The fish farmer must ensure that all other relevant approvals have been obtained.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, the class of persons specified in Schedule 1 and Brad March Fishing Charters, P.O. Box 513, Glenelg, S.A. 5045 (hereinafter referred to as the 'charter boat operator') are exempt from the provisions of clause 71AA and clause 70 (b) of Schedule 1 of the Fisheries (General) Regulations 1984, and section 41 of the Fisheries Act 1982, insofar as the charter boat operator may exceed the boat limits as specified in Schedule 2, subject to the conditions specified in Schedule 3.

SCHEDULE 1

Any person or persons who charter the boat *Stormbird* (hereinafter referred to as the 'permitted boat') from the charter boat operator in South Australia, for the purpose of recreational fishing for scalefish, abalone and rock lobster.

SCHEDULE 2

- 1. The charter boat operator may engage in the taking of no more than one rock lobster (*Jasus edwardsii*) per paying passenger in any one day where the number of paying passengers exceeds eight.
- 2. The charter boat operator may engage in the taking of no more than one abalone (*Haliotis spp.*) per paying passenger in any one day where the number of paying passengers exceeds 10.
- 3. The charter boat operator may engage in the taking of no more than 20 blue swimmer crab (*Portunus pelegicus*) per paying passenger in any one day where the number of paying passengers exceeds six.
- 4. The charter boat operator may engage in the taking of no more than one half of the daily bag limit for those species of scalefish subject to such a limit as specified in the Fisheries (General) Regulations 1984, per paying passenger in any one day where the number of paying passengers exceeds five.

SCHEDULE 3

- 1. This exemption is valid from the date of gazettal of this notice until $30 \, \text{June} \, 2000$.
- 2. The charter boat operator shall not use any other boats for the purpose of engaging in the permitted activity except the permitted boat.
- 3. The charter boat operator shall not sell any fish taken pursuant to this notice.
- 4. The charter boat operator shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act except where specifically exempted by this notice.
- 5. While engaged in the permitted activity the charter boat operator shall have in their possession a copy of this notice. Such notice must be produced to a PIRSA Fisheries and Aquaculture Compliance Officer is such an officer requests that it be so produced.
