FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Dr Jason Tanner (hereinafter referred to as the 'permit holder') of the South Australian Research and Development Institute (SARDI), P.O. Box 120 Henley Beach, S.A. 5211 is exempt from section 41 of the Fisheries Act 1982, subject to the conditions specified in Schedule 1, in that the permit holder shall not be guilty of an offence when conducting the activities specified in Schedule 1 (hereinafter referred to as the 'permitted activity') from the waters specified in Schedule 2, subject to the conditions specified in Schedule 3 from the date of gazettal of this notice until 29 October 1999.

SCHEDULE 1

The taking of western king prawn (*Penaeus latisulcatus*), slipper lobster (*Bacus* spp.) and calamary squid (*Sepioteuthis australis*) (hereinafter referred to as the permitted species) using a trawl net or nets, at any one time where the combined length of the headlines of all the nets used does not exceed 27.43 m, for the purpose of trade or business.

SCHEDULE 2

The waters of Gulf St Vincent within the area bounded by a line commencing at the intersection of the southern shore of Yorke Peninsula at high water mark with the meridian 137°E longitude, then proceeding due south along that meridian to its intersection with the northern shore of Kangaroo Island at high water mark, then easterly along that shore at high water mark to

Cape St. Alban (latitude 35°48.7'S, longitude 138°07.4'E), then in a direction of 030°T to Porpoise Head on the southern shore of Fleurieu Peninsula (latitude 35°39.6'S, longitude 138°13.6'E), then along the high water mark of the eastern and western shoreline of Gulf St. Vincent back to the point of commencement.

SCHEDULE 3

1. The permit holder must notify the PIRSA Fisheries and Aquaculture Compliance Unit on 1800 065 522 at least two hours prior to conducting the permitted activity.
2. All species taken pursuant to this notice other than the permitted species are for research purposes only and must not be sold.
3. The permitted activity may only be conducted from the boat *Jillian Sandra*.
4. Whilst engaged in the permitted activity the permit holder must have in his possession a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries and Aquaculture Compliance Officer.
5. The permit holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.
