FISHERIES ACT 1982: SECTION 59

TAKE notice that, pursuant to section 59 of the Fisheries Act 1982, David Warland (hereinafter referred to as the 'permit holder'), P.O. Box 2236, Port Lincoln, S.A. 5606 is exempt from the Fisheries Act 1982, insofar that he shall not be guilty of an offence when engaging in the activities specified in Schedule 1 (hereinafter referred to as the 'permitted activity') subject to the conditions specified in Schedule 2 from the waters described in Schedule 3 from the date of gazettal of this notice until 31 December 1999.

The collection of marine plankton using one plankton net.

SCHEDULE 2

1. All specimens taken shall be for the establishment of a broodstock culture only and may not be sold.

2. Before collecting any specimens pursuant to this notice, the permit holder must notify PIRSA Fisheries and Aquaculture on (1800 065 522) with details of the proposed location and dates on which collections are to be made.

3. The permit holder shall only conduct the activity from registered fish farms with the approval of the fish farm owner.

4. Whilst engaged in the permitted activity the permit holder must be in possession of a copy of this notice. Such notice must be produced to a PIRSA Fisheries and Aquaculture Compliance Officer if such an officer requests that it be produced.

5. The permit holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically permitted by this notice.

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Peter Rasmussen (M277), 3 Bockleburg Street, Streaky Bay, S.A. 5680 (hereinafter referred to as the 'fisher') is exempt from the provision of Schedule 1, clause 63 of the Fisheries (General) Regulations 1984, subject to the conditions specified in Schedule 1, in that the fisher shall not be guilty of an offence when taking up to 150 razor fish (*Pinna bicolor*) in any one day, from South Australian coastal marine waters from the date of gazettal of this notice until 30 June 2000.

SCHEDULE 1

1. All razor fish (Pinna bicolor) taken shall be used for bait only.

2. The total number of razor fish (*Pinna bicolor*) taken in any one day, shall be no greater than 150.

3. The fisher must include all razor fish (*Pinna bicolor*) taken under this permit on his monthly catch and effort summary provided to the South Australian Research and Development Institute (SARDI).

4. The fisher shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, John Paleologoudias (M518), 41 Sussex Street, Glenelg, S.A. 5045 (hereinafter referred to as the 'fisher') is exempt from the provision of Schedule 1, clause 63 of the Fisheries (General) Regulations 1984, subject to the conditions specified in Schedule 1, in that the fisher shall not be guilty of an offence when taking up to 150 razor fish (*Pinna bicolor*) in any one day, from South Australian coastal marine waters from the date of gazettal of this notice until 30 June 2000.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, those persons specified in Schedule 1 (hereinafter referred to as the 'fisher'), are exempt from section 44 (1) of the Fisheries Act 1982, insofar as the fisher may take fish for trade or business whilst not being the holder of a licence pursuant to regulations made under the Fisheries Act 1982 (hereinafter referred to as the 'permitted activity') subject to the conditions outlined in Schedule 2 during the period 30 September 1999 to 20 October 1999 or until this notice is revoked, whichever being the earlier.

SCHEDULE 1

Those persons who held a licence pursuant to the Scheme of Management (River Fishery) Regulations 1991 during the licensing year 1998-99 and who have paid all fees due for the 1998-99 year.

SCHEDULE 2

1. All fishing activity conducted pursuant to this notice must be conducted in accordance with the conditions and endorsements applicable to the last licence held by the fisher for the 1998-99 licensing year; and

2. The fisher shall not contravene or fail to comply with the Fisheries Act 1982 or any regulations made under that Act, except where specifically exempted by this notice. Dated 30 September 1999.
