FISHERIES ACT 1982: SECTION 59

TAKE notice that Craig Styan (hereinafter referred to as the 'exemption holder') or Kate Hutson acting as his agent, of the Department of Zoology, The University of Melbourne, Parkville, Vic. 3052, is exempt from the provisions of section 41 of the Fisheries Act 1982, but only insofar as the exemption holder shall not be guilty of an offence when taking undersized fish of the species scallop (Family Pectinidae) and when taking fish of the species scallop (Family Pectinidae) in excess of the daily bag limit (hereinafter referred to as the 'exempted activity') in the waters specified in Schedule 2, subject to the conditions specified in Schedule 1, from the date of gazettal of this notice until 30 December 2001.

SCHEDULE 1

1. The exemption holder may take no more than 300 scallops (Family Pectinidae) per day.
2. The exemption holder must not release scallops back into the water at a distance which is greater than one kilometre from the location that they were taken from.
3. Any fish taken by the exemption holder pursuant to this notice are for research purposes only and must not be sold.
4. The exemption holder must provide the Director of Fisheries with a copy of the research report on completion of the research project.
5. At least 24 hours prior to collecting any specimens pursuant to this notice, the exemption holder must advise a PIRSA Fisheries Compliance Officer on 1800 065 522 with details of the proposed locations and the dates on which the exempted activity will be conducted.
6. While engaged in the exempted activity, the exemption holder shall carry or have about or near his person, a copy of this notice. Such notice must be produced to a PIRSA Fisheries Compliance Officer upon request.
7. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulation made under that Act, except where specifically exempted by this notice.

SCHEDULE 2

The waters of Gulf St. Vincent which are north of the geodesic joining Troubridge Point, Yorke Peninsula and Cape Jervis, Fleurieu Peninsula and the waters of Spencer Gulf which are north of the geodesic joining Cape Catastrophe, Eyre Peninsula and Cape Spencer, Yorke Peninsula.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Mario Georgaris (hereinafter referred to as the 'exemption holder'), 25 Richard Avenue, Mitchell Park, S.A. 5043, holder of marine scalefish fishery licence number M171, is exempt from the provision of Schedule 1, clause 61 of the Fisheries (General) Regulations 2000 subject to the conditions specified in Schedule 1, in that the exemption holder shall not be guilty of an offence when taking up to 150 razor fish (*Pinna bicolor*) in any one day, from South Australian coastal marine waters from the date of gazettal of this notice until 30 June 2001.

SCHEDULE 1

1. All razor fish (*Pinna bicolor*) taken shall be used for bait only.
2. The total number of razor fish (*Pinna bicolor*) taken in any one day, shall be no greater than 150.
3. The exemption holder must include all razor fish (*Pinna bicolor*) taken under this permit on his monthly catch and effort summary provided to the South Australian Research and Development Institute (SARDI).
4. Whilst engaged in the collection activity the exemption holder must have in or about his possession a copy of this notice and produce that notice to a PIRSA Fisheries Compliance Officer forthwith, if and when an officer requests the exemption holder to produce it.
5. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Mardi van der Wielen of The University of Adelaide Department of Soil and Water, Waite Campus PMB1, Glen Osmond, S.A. 5064 (hereinafter referred to as the 'exemption holder') is exempt from the provisions of the Fisheries Act, 1982, but only insofar as the exemption holder may engage in the activities specified in Schedule 1 (hereinafter referred to as the 'exempted activity'), subject to the conditions specified in Schedule 2 from the date of gazettal of this notice until 30 December 2000.

SCHEDULE 1

The release of carp (family cyprinidae) into up to 6 enclosures with a maximum diameter of 4.5 m, and a maximum height of 0.9 m placed, within the waters of Little Duck Lagoon and Carp Inlet of the Gurra Lakes system.

SCHEDULE 2

1. All fish used pursuant to this exemption must be destroyed and not returned to the water on completion of scientific evaluation.
2. Before releasing any specimens pursuant to this notice, the exemption holder must advise the PIRSA Fisheries Compliance Unit on 1800 065 522 with details of the proposed locations and the dates on which the releases are to be made.
3. While engaging in the exempted activity, the exemption holder must be in possession of a copy of this notice. Such notice must be produced to a PIRSA Fisheries Compliance Officer if such an officer requests that it be produced.
4. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that, pursuant to section 59 of the Fisheries Act 1982, N. D. and W. P. Ramsey of Clean Seas Aquaculture Pty Ltd (hereinafter referred to as the 'exemption holder'), P.O. Box 80, Arno Bay, S.A. 5603 exempt from the Fisheries Act 1982, insofar as they may take yellowtail kingfish (*Seriola lalandi*) for the purpose of aquaculture broodstock in the waters specified in Schedule 1 subject to the conditions in Schedule 2 (hereinafter referred to as the 'exempted activity') from date of gazettal of this notice until 30 November 2000.

SCHEDULE 1

South Australian coastal marine waters of Spencer Gulf north of latitude 32°48.54'S except for areas gazetted as aquatic reserves

SCHEDULE 2

1. The exemption holder may take a maximum of 7 yellowtail kingfish (*Seriola lalandi*). All yellowtail kingfish taken pursuant to this notice may not be sold or transferred to another party.

2. The exempted activity may only be conducted by Craig Edwards, holder of marine scalefish fishery licence number M128.

3. All yellowtail kingfish taken pursuant to this notice must be kept on the registered aquaculture site of landbased aquaculture licence number FT00560.

4. The exemption holder shall notify the PIRSA Fisheries Compliance Unit on 1800 065 522 at least 24 hours prior to conducting the exempted activity with the following information:

- details of the boat that will be used to engage in the exempted activity;
- the name of the person who will be conducting the exempted activity;
- the intended place and time of launching and retrieval of the nominated boat for that day; and
- the intended area of conducting the exempted activity.

5. The exemption holder shall record the number of wild broodstock held pursuant to this notice in a register to be maintained at the registered aquaculture site, which must be made available for inspection by a PIRSA Fisheries Compliance Officer upon request.

6. The exemption holder shall provide within 14 days of the completion of the exempted activity a written report on the number of fish taken, specific location and their condition to the Director of Fisheries.

7. PIRSA Fisheries Compliance Unit retains the right for a departmental officer to accompany the exemption holder at any time during the exempted activity.

8. While engaged in the exempted activity the exemption holder shall carry or have about or near his person a copy of this notice. Such notice must be produced to a PIRSA Fisheries Compliance Officer upon request.

9. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982 or any regulations made under that Act, except where specifically exempted by this notice.
