ESSENTIAL SERVICES COMMISSION

Country Equalisation Scheme—Notice of determination of categories of small customers and equivalent country rates

PURSUANT to clause 8.2(e) of the Electricity Pricing Order (EPO), notice is given that the Essential Services Commission has determined the categories for small customers (in accordance with clause 8.2(c)(i)) and the equivalent country rate for each category of small customer (in accordance with clause 8.2(c)(ii)) to apply from 1 January 2003.

For the purpose of clause 8.2(c)(i) of the Electricity Pricing Order (EPO), the categories for small customers are determined to be:

- Residential; and
- Business

“Residential” category is defined as consumption in premises used wholly or principally as private residence.

“Business” is defined as all small customers, other than those in the residential category.

For the purpose of clause 8.2(c)(ii) of the Electricity Pricing Order (EPO), the equivalent country rate for each category of small customers is determined to be:

- Residential: \$1 000/MWh, excluding GST
- Business: \$510/MWh, excluding GST
