### **FISHERIES ACT 1982: SECTION 59**

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Antony W. Smith, P.O. Box 1375, Berri, S.A. 5343, holder of licence R54, pursuant to the Scheme of Management (River Fishery) Regulations 1991, (hereinafter referred to as the 'exemption holder') is exempt from section 41 of the Fisheries Act 1982, but only insofar as the exemption holder may take fish for trade or business using a haul net of a maximum length of 240 m with a minimum mesh size of 100 mm and a maximum drop of 2.7 m (hereinafter referred to as the 'exempted activity'), subject to the conditions outlined in Schedule 1, from the date of gazettal of this notice until 30 November 2002, or unless this exemption is varied or revoked earlier.

#### **SCHEDULE 1**

1. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982 or any regulations made under that Act, except where specifically exempted by this notice.

2. The exempted activity cannot be undertaken in the mainstream of the River Murray.

3. While undertaking the exempted activity, the exemption holder shall only take European carp (*Cyprinus carpio*) bony bream (*Nematalosa eribi*) and non-native species from permitted backwaters.

4. Fish, other than carp, bony bream and non-natives must be immediately returned to the water unencumbered in any way and with as little injury as possible where such fish are taken in backwater fishing operations.

5. While undertaking the exempted activity, the exemption holder may use a gaff or dab net to remove fish from the netting operation.

6. The hauling net must not be used as a set net in backwaters.

7. The exemption holder must notify the PIRSA Fisheries Compliance Unit on 1800 065 522 at least 24 hours prior to conducting the exempted activity and provide the following information:

- (a) the name and licence number of the exemption holder;
- (b) the intended fishing area; and
- (c) the intended fishing period.

8. Whilst engaged in the exempted activity, the exemption holder must be in possession of a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries Compliance Officer.

### **FISHERIES ACT 1982: SECTION 59**

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Mario Georgaras (hereinafter referred to as the 'exemption holder'), 25 Richard Avenue, Mitchell Park, S.A. 5043, holder of Marine Scalefish Fishery Licence No. M171, is exempt from the provision of Clause 61 of Schedule 1 of the Fisheries (General) Regulations 2000, subject to the conditions specified in Schedule 1, in that the exemption holder shall not be guilty of an offence when taking up to 150 razor fish (*Pinna bicolor*) in any one day, from South Australian coastal marine waters from the date of gazettal of this notice until 30 June 2003, unless varied or revoked earlier.

#### **SCHEDULE 1**

1. All razor fish (*Pinna bicolor*) taken shall be used for bait only.

2. The total number of razor fish (*Pinna bicolor*) taken in any one day, shall be no greater than 150.

3. The exemption holder must include all razor fish (*Pinna bicolor*) taken under this permit on his monthly catch and effort summary provided to the South Australian Research and Development Institute (SARDI).

4. Whilst engaged in the collection activity the exemption holder must have in or about his possession a copy of this notice and produce that notice to a PIRSA Fisheries Compliance Officer forthwith, if and when an officer requests the exemption holder to produce it.

5. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.

#### FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Jacqueline Pocklington or persons acting as her agents (hereinafter referred to as the 'exemption holder') from the School of Biological Sciences, Flinders University of South Australia, G.P.O. Box 2100, Adelaide, S.A. 5001, is exempt from the provisions of sections 41 and 48G of the Fisheries Act 1982, but only insofar as to engage in the activities described in Schedule 1 in the Aldinga Reef Aquatic Reserve, (hereinafter referred to as the 'exempted activity'), subject to the conditions set out in Schedule 2, from the date of gazettal of this notice until 31 December 2003, unless varied or revoked earlier.

#### SCHEDULE 1

- The removal of all aquatic organisms from up to 32 plots, each with a maximum area of 0.25 m<sup>2</sup>, within the intertidal zone of the Aldinga Reef Aquatic Reserve.
- The collection of up to a maximum of 60 specimens from the Aldinga Reef Aquatic Reserve for the purpose of identification.
- The drilling of four holes for the anchoring and placement of a data logger.

#### SCHEDULE 2

1. The specimens collected by the exemption holder are for scientific and research purposes only and may not be sold.

2. Collections undertaken in the Aldinga Reef Aquatic Reserve must be undertaken with due consideration of other members of the public already in the area.

3. Before undertaking any exempted activity pursuant to this notice, the exemption holder must advise a PIRSA Fisheries Compliance Officer on 1800 065 522 with details of the proposed locations and the dates on which the exempted activity is to be undertaken.

4. While engaging in the exempted activity, the exemption holder must be in possession of a copy of this notice. Such notice must be produced to a PIRSA Fisheries Compliance Officer if such an officer requests that it be produced.

5. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.
