FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Alan Payne (hereinafter referred to as the 'exemption holder'), P.O. Box 98, Streaky Bay, S.A. 5680, holder of Marine Scalefish Fishery Licence No. M384, is exempt from the provision of Clause 61 of Schedule 1 of the Fisheries (General) Regulations 2000, but only insofar as the exemption holder shall not be guilty of an offence when taking up to 150 razor fish (*Pinna bicolor*) in any one day from South Australian coastal marine waters (hereinafter referred to as the 'exempted activity'), subject to the conditions specified in Schedule 1, from the date of gazettal of this notice until 30 June 2003, unless varied or revoked earlier.

SCHEDULE 1

1. All razor fish (*Pinna bicolor*) taken pursuant to this notice shall be used for bait only.
2. The total number of razor fish (*Pinna bicolor*) taken in any one day, shall be no greater than 150.
3. The exemption holder must include all razor fish (*Pinna bicolor*) taken under this notice on his monthly catch and effort summary provided to the South Australian Research and Development Institute (SARDI).
4. Whilst engaged in the exempted activity the exemption holder must have in or about his possession the copy of this notice and produce that notice to a PIRSA Fisheries Compliance Officer forthwith, if and when an officer requests the exemption holder to produce it.
5. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Gavin T. Starkey (hereinafter referred to as the 'exemption holder'), c/o P.O., Port Kenny, S.A. 5671, holder of Marine Scalefish Fishery Licence No. M437, is exempt from the provision of Clause 61 of Schedule 1 of the Fisheries (General) Regulations 2000, but only insofar as the exemption holder shall not be guilty of an offence when taking razor fish (*Pinna bicolor*) from South Australian coastal marine waters (hereinafter referred to as the 'exempted activity'), subject to the conditions specified in Schedule 1, from the date of gazettal of this notice until 30 June 2003, unless varied or revoked earlier.

SCHEDULE 1

1. All razor fish (*Pinna bicolor*) taken pursuant to this notice shall be used for bait only.
2. The total number of razor fish (*Pinna bicolor*) taken in any one day, shall be no greater than 150.
3. The exemption holder must include all razor fish (*Pinna bicolor*) taken under this notice on his monthly catch and effort summary provided to the South Australian Research and Development Institute (SARDI).
4. Whilst engaged in the exempted activity the exemption holder must have in or about his possession the copy of this notice and produce that notice to a PIRSA Fisheries Compliance Officer forthwith, if and when an officer requests the exemption holder to produce it.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Roger Edwards, c/o SARLAC, Level 1, 16 Unley Road, Parkside, (hereinafter referred to as the 'exemption holder') and his permitted agents are exempt from regulations 86 and 87 of the Fisheries (General) Regulations 2000, in that the exemption holder shall not be guilty of an offence only insofar as being permitted to take rock lobster out of season for industry promotion purposes (hereinafter referred to as the 'permitted activity'), subject to the conditions specified in Schedule 1, and in accordance with the dates and locations specified in Schedule 2.

SCHEDULE 1

1. The exemption holder must use the services of a licence holder in a rock lobster fishery to engage in the permitted activity, as his agent(s).

2. The permit holder must notify the Fisheries Compliance Unit on 1800 065 522 at least two hours prior to conducting the permitted activity, with the names of the licence holders and registered boats to be used and the port from which the boat will leave for the permitted activity.

3. The permit holder must allow one or more fisheries officers to be present on board a boat used for the permitted activity, if requested.

4. The permit holder and his agents must comply with all instructions of a fisheries officer with respect to the permitted activity in addition to the conditions set out herein.

5. All rock lobster taken at Robe must be returned to the water alive and unharmed as soon as possible after the completion of the promotional event.

6. Only a maximum of 20 rock lobsters can be taken at Vivonne Bay and those lobsters not required to be cooked as part of the promotional event must be returned to the water alive and unharmed as soon as possible after the completion of the promotional event.

7. The permit holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.

SCHEDULE 2

In the waters adjacent to Vivonne Bay, on 17 September 2002, and 18 September 2002 if required.

In the waters adjacent to Robe, on 17 September 2002 and 18 September 2002.
