FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Rockne Little of Rainbow South Pacific Export Ltd, P.O. Box 1235, Coultia, S.A. 5607 (the 'exemption holder') is exempt from section 34 of the Fisheries Act 1982 and the Scheme of Management (Miscellaneous Fishery) Regulations 1991 but only insofar as he may take sea urchins (Family Echinometridae) for the purposes of trade or business (the 'exempted activity'), subject to the conditions in Schedule 1, from 1 October 2003 to 30 June 2004, unless varied or revoked earlier.

SCHEDULE 1

1. Sea urchins may be taken from coastal waters of the State excluding the waters of Coffin Bay south of latitude 34°30.30'S."

2. The exemption holder may authorise a person to act on his behalf in conducting the exempted activity (the 'nominated person'). Before the nominated person undertakes fishing activity pursuant to this notice, the exemption holder must contact PIRSA Fishwatch on 1800 065 522 and provide the following information:

- the full name of the nominated person; and
- the residential address of the nominated person.

3. The nominated person may undertake fishing activity pursuant to this exemption for a maximum of 21 days within the period 1 October 2003 to 30 June 2004.

4. The exemption holder or the nominated person must be present at all times during which fishing activity is undertaken pursuant to this exemption.

5. The exemption holder (or the nominated person) may have two other persons assisting them at any one time whilst undertaking the exempted activity. The persons assisting the exemption holder must, at all times whilst conducting the exempted activity, remain within 50 m of the exemption holder.

6. Sea urchins may only be taken by hand.

7. The exemption holder must provide the Director of Fisheries with statistical catch and effort information (including zero returns if no fishing operations have been conducted), in the form of a daily log, within 15 days of the completion of each calendar month.

8. The exemption holder must notify PIRSA Fishwatch on 1800 065 522 at least one hour prior to conducting the exempted activity with the following information:

- details of the boat that will be used to engage in the exempted activity;
- the intended area of conducting the exempted activity;
- the intended place and time of launching and retrieval of the nominated boat for that day; and
- the name of the assistants (if any) who will be assisting the exemption holder or the nominated person.

9. The exemption holder or nominated person must allow a PIRSA Fisheries departmental officer to accompany them at any time whilst conducting the exempted activity.

10. The exemption holder or his assistants must not conduct any other fishing activity whilst undertaking the exempted activity.

11. While engaged in the exempted activity the exemption holder (or the nominated person) must carry or have about or near his person a copy of this notice. Such notice must be produced to a PIRSA Fisheries Officer upon request.

12. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.

## FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Terry Scott c/o Post Office, Coffin Bay, S.A. 5607 (the 'exemption holder') is exempt from section 34 of the Fisheries Act 1982 and the Scheme of Management (Miscellaneous Fishery) Regulations 1991, but only insofar as he may take sea urchins (Family Echinometridae) for the purposes of trade or business (the 'exempted activity'), subject to the conditions in Schedule 1, from 1 October 2003 to 30 June 2004, unless varied or revoked earlier.

## SCHEDULE 1

1. Sea urchins may be taken from coastal waters of the State including the waters of Coffin Bay.

2. The exemption holder may authorise a person to act on his behalf in conducting the exempted activity (the 'nominated person'). Before the nominated person undertakes fishing activity pursuant to this notice, the exemption holder must contact PIRSA Fishwatch on 1800 065 522 and provide the following information:

- the full name of the nominated person; and
- the residential address of the nominated person.

3. The nominated person may undertake fishing activity pursuant to this exemption for a maximum of 21 days within the period 1 October 2003 to 30 June 2004.

4. The exemption holder or the nominated person must be present at all times during which fishing activity is undertaken pursuant to this exemption.

5. The exemption holder (or the nominated person) may have two other persons assisting them at any one time whilst undertaking the exempted activity. The persons assisting the exemption holder must, at all times whilst conducting the exempted activity, remain within 50 m of the exemption holder.

6. Sea urchins may only be taken by hand.

7. The exemption holder must provide the Director of Fisheries with statistical catch and effort information (including zero returns if no fishing operations have been conducted), in the form of a daily log, within 15 days of the completion of each calendar month.

8. The exemption holder must notify PIRSA Fishwatch on 1800 065 522 at least one hour prior to conducting the exempted activity with the following information:

- details of the boat that will be used to engage in the exempted activity;
- the intended area of conducting the exempted activity;
- the intended place and time of launching and retrieval of the nominated boat for that day; and
- the name of the assistants (if any) who will be assisting the exemption holder or the nominated person.

9. The exemption holder or nominated person must allow a PIRSA Fisheries departmental officer to accompany them at any time whilst conducting the exempted activity.

10. The exemption holder or his assistants must not conduct any other fishing activity whilst undertaking the exempted activity.

11. While engaged in the exempted activity the exemption holder (or the nominated person) must carry or have about or near his person a copy of this notice. Such notice must be produced to a PIRSA Fisheries Officer upon request.

12. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982 or any regulations made under that Act, except where specifically exempted by this notice.

## FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Bernard Starkey, holder of Marine Scalefish Fishery Licence No. M436, c/o Post Office, Port Kenny, S.A. 5671 (the 'exemption holder') is exempt from clause 61 of Schedule 1 of the Fisheries (General) Regulations 2000 but only insofar as the exemption holder shall not be guilty of an offence when taking up to 150 razor fish (*Pinna bicolor*) in any one day from South Australian coastal waters (the 'exempted activity'), subject to the conditions specified in Schedule 1 of this notice, from the date of gazettal of this notice until 30 June 2004, unless varied or revoked earlier.

## SCHEDULE 1

1. The exemption holder may only engage in the exempted activity when fishing pursuant to Marine Scalefish Fishery Licence No. M436.

2. All razor fish (*Pinna bicolor*) taken pursuant to this notice must be used for bait only and must not be sold.

3. The total number of razor fish (*Pinna bicolor*) taken in any one day must not exceed 150.

4. The exemption holder must include all razor fish (*Pinna bicolor*) taken in accordance with this exemption on the monthly catch and effort summary provided to the South Australian Research and Development Institute (SARDI).

5. Whilst engaged in the exempted activity the exemption holder must have in his possession a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries Officer.

6. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.

## FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Gavin T. Starkey, holder of Marine Scalefish Fishery Licence No. M437, 9 Main Street, Port Kenny, S.A. 5671 (the 'exemption holder') is exempt from clause 61 of Schedule 1 of the Fisheries (General) Regulations 2000 but only insofar as the exemption holder shall not be guilty of an offence when taking up to 150 razor fish (*Pinna bicolor*) in any one day from South Australian coastal waters (the 'exempted activity'), subject to the conditions specified in schedule 1 of this notice, from the date of gazettal of this notice until 30 June 2004, unless varied or revoked earlier.

## SCHEDULE 1

1. The exemption holder may only engage in the exempted activity when fishing pursuant to Marine Scalefish Fishery Licence No. M437.

2. All razor fish (*Pinna bicolor*) taken pursuant to this notice may be used for bait only and must not be sold.

3. The total number of razor fish (*Pinna bicolor*) taken in any one day must not exceed 150.

4. The exemption holder must include all razor fish (*Pinna bicolor*) taken in accordance with this exemption on the monthly catch and effort summary provided to the South Australian Research and Development Institute (SARDI).

5. Whilst engaged in the exempted activity the exemption holder must have in his possession a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries Officer.

6. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.

## FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Sam Costa of Apricot Grove 71, Ian Showell Drive, Renmark SA 5341 (the 'exemption holder') is exempt from clause 76 of Schedule 1 of the Fisheries (General) Regulations 2000 but only insofar as the exemption holder shall not be guilty of an offence when taking up to 60 Murray Cod (*Maccullochella peelii*) from the waters of the State (the 'exempted activity'), subject to the conditions specified in Schedule 1, from the date of gazettal of this notice until 31 December 2003, unless varied or revoked earlier.

## SCHEDULE 1

1. The exemption holder may only engage in the exempted activity during the period commencing 27 September 2003 to 31 December 2003.

2. The exemption holder may take up to a total of 60 Murray Cod for the purposes of research to be conducted by Deakin University, Warrnambool, Vic. 3280.

3. The exemption holder may only take a maximum of 45 male fish and a maximum of 15 female fish.

4. All fish taken pursuant to this notice must be a minimum length of 50 cm and a maximum length of 100 cm.

5. The exemption holder may only use drum nets and/or hooks to undertake the exempted activity.

6. The exemption holder must contact PIRSA Fishwatch Loxton Office on 8595 9148 or 0407 086 332 at least 2 hours prior to undertaking any fishing activity pursuant to this notice and provide the following details:

- the exact location of the fishing activity;
- the number and type of devices to be used;
- the predicted duration of the fishing activity.

7. Immediately following the taking of any Murray Cod, the exemption holder must contact PIRSA Fishwatch Loxton Office on 8595 9148 or 0407 086 332 and make arrangements to have the Murray Cod tagged in a way that allows each fish to be identified for the period that they are held by the exemption holder. The exemption holder must also provide the following details:

- number of fish taken;
- an estimated description of the fish including weight, length, and capture location;
- location the fish are going to be held.

8. The exemption holder must contact PIRSA Fishwatch Loxton Office on 8595 9148 or 0407 086 332, prior to relocating Murray Cod to a different holding facility. The exempt holder must provide the following details:

- number of Murray Cod to be transferred;
- location to which the Murray Cod are to be transferred;
- total number of Murray Cod held and details of all holding location(s).

9. The exemption holder may only be in possession of Murray Cod in South Australia that are tagged in accordance with this exemption.

10. The exemption holder must ensure all fishing devices are checked and all fish removed from those devices at least once during each 24 hour period.

11. The exemption holder must ensure all fishing devices are removed from the water at the completion of any fishing activity.

12. A floating white buoy of not less than 2 L in volume must be attached to all permitted gear whilst in use and all gear must be clearly marked with the exemption holder's name and the alpha-numeric identifier R04.

13. Any native species other than Murray Cod that are taken in the course of the exempted activity, or that interact with the gear used in accordance with this notice, must be returned to the water immediately.

14. Whilst engaged in the exempted activity the exemption holder must have in his possession a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries Compliance Officer.

15. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.
