FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, the class of persons specified in Schedule 1 (the 'exemption holders'), are exempt from clauses 66, 70, 73, 77A, 77B and 77C of Schedule 1 of the Fisheries (General) Regulations 2000, but only insofar as the exemption holders may exceed the prescribed boat limits during a chartered fishing trip in accordance with the allowable limits specified in Schedule 2 (the 'exempted activity'), subject to the conditions specified in Schedule 3, from 1 July 2005 until 31 July 2005, unless varied or revoked earlier.

SCHEDULE 2

1. Where the number of 'other exemption holders' exceeds six, all of the 'other exemption holders' on board the boat are each restricted to taking no more than one half of the daily bag limit (rounded up to the nearest whole number if necessary) for those species of scalefish (except King George whiting) subject to a limit as specified in the Fisheries (General) Regulations 2000 in any one day. 2. Where the number of 'other exemption holders' exceeds three, all of the 'other exemption holders' on board the boat are each restricted to taking no more than 10 King George whiting in any one day.

3. Where the number of 'other exemption holders' exceeds 10, each 'other exemption holder' may take no more than one abalone in any one day.

4. Where the number of 'other exemption holders' exceeds eight, all of the 'other exemption holders' on board the boat are each restricted to taking no more than one rock lobster in any one day.

5. Where the number of 'other exemption holders' exceeds six, all of the 'other exemption holders' on board the boat are each restricted to taking no more than eight cuttlefish or eight calamary or eight cuttlefish and/or calamary in combination, in any one day.

6. Where the number of 'other exemption holders' exceeds six, all of the 'other exemption holders' on board the boat are each restricted to taking no more than 20 blue crabs or 20 sand crabs or 20 blue crabs and/or sand crabs in combination in any one day.

7. Where the number of 'other exemption holders' exceeds six, all of the 'other exemption holders' on board the boat are each restricted to taking either one gummy shark or one school shark in any one day.

SCHEDULE 3

1. The principal exemption holder, its employees or agents must not take any fish during the chartered fishing trip.

2. Neither the principal exemption holder nor the other exemption holders may sell any fish taken pursuant to this notice.

3. The principal exemption holder must not accept any fish taken by the other exemption holders as all or part of the consideration for the charter agreement.

4. The principal exemption holder must contact PIRSA Fishwatch on 1800 065 522 at least two hours prior to commencing the exempted activity and advise of the time and date of departure and the estimated time of return to port.

5. The exemption holders must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, the holder of a prawn fishery licence issued pursuant to the Fisheries (Scheme of Management—Prawn Fisheries) Regulations 1991 for the West Coast Prawn Fishery listed in Schedule 1 (the 'exemption holders') or their registered master are exempt from the notices made under section 43 of the Fisheries Act 1982 prohibiting the taking of western king prawns (*Melicertus latisulcatus*), in that the exemption holders shall not be guilty of an offence when using prawn trawl nets in accordance with the conditions of their fishery licence for the purpose of stock assessment survey (the 'exempted activity') subject to the conditions contained in Schedule 2.

SCHEDULE 2

1. The exemption is valid from 1800 hours on 2 July 2005 until 0700 hours on 3 July 2005.

2. The exemption holder must comply with the instructions from Cameron Dixon, Senior Research Scientist, SARDI Aquatic Sciences and work in the allotted trawl area in the Coffin Bay trawl grounds.

3. All fish, other than prawns, southern calamary, arrow squid, scallops, octopus and slipper lobster taken during the exempted activity for stock assessment purposes, are to be returned to the water immediately after capture.

4. While engaged in the exempted activity or unloading of the survey catch, the exemption holder must have on board their boat or near his person a copy of this notice. Such notice must be produced to a PIRSA Fisheries Compliance Officer if requested.

5. The exemption holder must not contravene or fail to comply with Fisheries Act 1982, or any other regulations made under that Act except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Stephen Morris, c/o P.O. Box 68, Woodcroft, S.A. 5162 (the 'exemption holder'), or a person acting as his agent, is exempt from Schedule 1 of the Fisheries (General) Regulations 2000, but only insofar as the exemption holder shall not be guilty of an offence when using the number and type of devices specified in Schedule 2 when taking carp (Family Cyprinidae) for the purposes of trade or business from waters specified in Schedule 1, (the 'exempted activity'), subject to the conditions specified in Schedule 3, from 5 July 2005 until 30 June 2006, unless varied or revoked earlier.

SCHEDULE 3

1. All species other than carp (Family Cyprinidae) taken in the course of the exempted activity must be immediately returned to the water excluding non-native species, which must not be returned to the water alive.

2. The exemption holder must remove all fish and other material from the devices at least once in every 24-hour period.

3. All live carp must be stored in tanks at Lot 5, Pelican Point Road, Outer Harbour (FT00746).

4. The exemption holder must notify PIRSA Fisheries on 1800 065 522 at least two hours prior to conducting the exempted activity and answer a series of questions about the exempted activity. The exemption holder will need to have a copy of the exemption at the time of making the call, and be able to provide information about the area and time of the exempted activity, the vehicles and boats involved, the number of agents undertaking the exempted activity and other related questions.

5. While engaged in the exempted activity, the exemption holder or his agents must be in possession of a copy of this notice. The exemption holder must also provide each of the agents with a short letter confirming that they may act as his agents. A copy of this notice and such a letter must be produced to a PIRSA Fisheries Compliance Officer if requested.

6. The exemption holder must provide a report in writing detailing the outcomes of the collection of organisms pursuant to this notice to the Director of Fisheries, (G.P.O. Box 1625, Adelaide, S.A. 5001) every six months, giving the following details:

- · the date and time of collection; and
- the numbers of carp collected.

7. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.
