under section 7 of the *Administrative Arrangements Act 1994*

1—Short title

This proclamation may be cited as the *Administrative Arrangements (Constitution of Ministers as Bodies Corporate) Proclamation 2006*.

2—Commencement

This proclamation comes into operation on the day on which it is made.

3—Dissolution of certain bodies corporate

The bodies corporate referred to in Schedule 1 are dissolved.

4—Constitution of certain Ministers as bodies corporate

The Ministers referred to in Schedule 2 are constituted as bodies corporate.

5—Vesting of certain assets, rights and liabilities

- (1) The assets, rights and liabilities of the former body corporate known as the Minister Assisting the Premier in Economic Development are vested in and attached to the Minister for Economic Development.
- (2) The assets, rights and liabilities of the former body corporate known as the Minister for Administrative Services are vested in and attached to the Minister for Administrative Services and Government Enterprises.

under section 6 of the *Administrative Arrangements Act 1994*

1—Short title

This proclamation may be cited as the *Administrative Arrangements (Conferral of Ministerial Functions and Powers) Proclamation 2006*.

2—Commencement

This proclamation comes into operation on the day on which it is made.

3—Conferral of ministerial functions and powers

The ministerial functions and powers of the Minister for State/Local Government Relations under Part 2 of the *City of Adelaide Act 1998* are conferred on the Minister for the City of Adelaide.

Administrative Arrangements (References to Ministers) Proclamation 2006

under section 8 of the *Administrative Arrangements Act 1994*

1—Short title

This proclamation may be cited as the *Administrative Arrangements (References to Ministers) Proclamation 2006*.

2—Commencement

This proclamation comes into operation on the day on which it is made.

3—Interpretative provision

- (1) A reference to the Minister for Administrative Services in an Act or a statutory instrument under an Act will, if the Act was on the day immediately before the effective date, committed to the administration of that Minister, have effect as if it were a reference to the Minister to whom the administration of the Act is for the time being committed.
- (2) A reference to the Minister for Administrative Services in a statutory instrument or any other kind of instrument, or a contract, agreement or other document, made or entered into before the effective date (other than a reference to which subclause (1) is applicable) will have effect as if it were a reference to the Minister for Administrative Services and Government Enterprises.
- (3) A reference to the Minister Assisting the Premier in Economic Development in an Act, a statutory instrument, or any other kind of instrument, or a contract, agreement or other document, will have effect as if it were a reference to the Minister for Economic Development.
- (4) A reference to a Minister not referred to in a preceding subclause in a statutory instrument or any other kind of instrument, or a contract, agreement or other document, made or entered into before the effective date, that is being administered, managed or held under or pursuant to a Ministerial responsibility or function that is, from the effective date, to be assumed by another Minister, will have effect as if it were a reference to that other Minister.
- (5) In this clause—
effective date means the date on which this proclamation is made.

2—Commencement

This proclamation comes into operation on the day on which it is made.
