**REPORT AND DETERMINATION OF THE REMUNERATION TRIBUNAL****TRAVELLING AND ACCOMMODATION ALLOWANCES****A. REPORT**

Adjustments have been made to these allowances having regard to the increased costs that have occurred since the Tribunal last adjusted them in April 2007 and to the increased travelling and accommodation allowances granted to the South Australian public sector.

**B. DETERMINATION****1. SCOPE OF DETERMINATION**

This Determination applies to Court Officers, Judges, and Statutory Officers.

**2. INTERPRETATION**

In this Determination, unless the contrary appears:

**“Court Officer”** means any of the following:

- the State Coroner;
- the Deputy State Coroner;
- Commissioners of the Environment, Resources and Development Court.

**“Judges”** means any of the following members of the judiciary:

- the Chief Justice of the Supreme Court;
- Puisne Judges of the Supreme Court;
- Masters of the Supreme Court;
- the Chief Judge of the District Court;
- Judges of the Environment, Resources and Development Court;
- Masters of the District Court;
- other District Court Judges;
- the Chief Magistrate;
- the Deputy Chief Magistrate;
- Supervising Magistrates;
- the Assisting Supervising Magistrate of the Adelaide Magistrates Court;
- Stipendiary Magistrates;
- the Supervising Industrial Magistrate;
- other Industrial Magistrates;
- the Senior Judge of the Industrial Relations Court and President of the Workers Compensation Tribunal;
- the President of the Industrial Relations Commission and Judge of the Industrial Relations Court;
- other Judges of the Industrial Relations Court who hold joint commissions in the Australian Industrial Relations Commission and the Industrial Relations Commission of South Australia.

**“Statutory Officers”** means any of the following statutory office holders:

- Deputy Presidents of the Industrial Relations Commission;
- Commissioners of the Industrial Relations Commission;
- the Auditor General;
- the Electoral Commissioner;
- the Ombudsman;

the Deputy Electoral Commissioner;  
the Employee Ombudsman;  
the Health and Community Services Complaints Commissioner.

3. **TRAVELLING AND ACCOMMODATION ALLOWANCES**

A person who actually incurs expenditure when travelling on official business and which necessitates absence from home overnight shall be paid an allowance as follows:

- 3.1 Outside the metropolitan area as defined by the *Development Act 1993* but within the State – at the rate of two hundred and twenty-one dollars (\$221) for each day that involves an overnight absence, plus any extra expenditure necessarily incurred.
- 3.2 Within the metropolitan area as defined by the *Development Act 1993* – at the rate of two hundred and fifty-seven dollars (\$257) for each day which involves an overnight absence, plus any extra expenditure necessarily incurred.
- 3.3 Interstate – at the rate of four hundred and twenty-four dollars (\$424) for Sydney and three hundred and ninety-two dollars (\$392) for places other than Sydney for each day which involves an overnight absence, plus any extra expenditure necessarily incurred.
- 3.4 When an additional period of less than 24 hours absence occurs without overnight accommodation, then a further payment calculated at the rate of one half of the allowance shall be paid with respect to the excess hours.
- 3.5 Reimbursement is not to be made for luncheon for single day absences within South Australia.
- 3.6 Employees who travel interstate and return on the same day may be reimbursed for luncheon on the basis of actual expenditure up to nineteen dollars and forty-five cents (\$19.45).

4. **DATE OF OPERATION**

The allowances prescribed in Clause 3 of this Determination shall operate on and from 5 May 2008 and supersede those prescribed in previous Determinations covering persons whose office is listed herein.

**REPORT AND DETERMINATION OF THE REMUNERATION TRIBUNAL**  
**MINISTERS OF THE CROWN AND OFFICERS AND MEMBERS OF PARLIAMENT**

**A. REPORT****1. INTRODUCTION**

- 1.1 Section 4(1)(c) of the *Parliamentary Remuneration Act 1990* confers jurisdiction on the Remuneration Tribunal to determine from time to time electorate allowances and other allowances and expenses for members of Parliament.
- 1.2 The last determination covering these matters was issued on March 2007, viz Determination No. 2 of 2007.

**2. TRAVELLING AND ACCOMMODATION ALLOWANCES FOR MINISTERS AND THE LEADER AND DEPUTY LEADER OF THE OPPOSITION**

- 2.1 Having regard to the increased travelling and accommodation allowances granted to the South Australian public sector and to Court Officers, Judges and Statutory Officers the Tribunal believes justification exists to increase these allowances. Consequently, the Tribunal has determined to provide equivalent increases to the travelling and accommodation allowances for Ministers of the Crown, the Leader of the Opposition and the Deputy Leader of the Opposition to operate on and from 5 May 2007.

**3. COUNTRY MEMBERS ACCOMMODATION ALLOWANCE**

- 3.1 Also having regard to increased accommodation allowances granted to the South Australian public sector and to Court Officers, Judges and Statutory Officers the Tribunal believes justification exists to increase the Country Members Accommodation allowance.

**B. DETERMINATION****1. SCOPE OF DETERMINATION**

This Determination applies to Ministers of the Crown, the Leader and Deputy Leader of the Opposition and the Country Members of Parliament.

**2. TRAVELLING AND ACCOMMODATION ALLOWANCES**

- 2.1 A Minister who actually incurs expenditure when travelling on official business shall be paid:
- 2.1.1 Outside the metropolitan area, as defined by the *Development Act 1993*, but within the State - up to two hundred and twenty-one dollars (\$221) per day;
- 2.1.2 Interstate - up to four hundred and twenty-four dollars (\$424) per day for Sydney and up to three hundred and ninety-two dollars (\$392) per day for places other than Sydney;
- 2.1.3 Any extra expenditure necessarily incurred in addition to the allowances provided in 2.1.1 and 2.1.2.



2.2 The allowances provided by this clause shall also be payable to the Leader of the Opposition who actually incurs expenditure when travelling on official business, and to the Deputy Leader of the Opposition when he or she deputises, at the Leader's request, for the Leader of the Opposition in his or her official capacity.

### **3. COUNTRY MEMBERS ACCOMMODATION ALLOWANCE**

3.1 A Member of either House of Parliament (including a Minister of the Crown or the Leader of the Opposition in the House of Assembly) whose usual place of residence is more than 75 kilometres by road from the General Post Office at Adelaide and who is required to stay in Adelaide overnight in order to attend not only to parliamentary duties but also to the Member's duty to be actively involved in community affairs and to represent and assist constituents in dealings with governmental and other public agencies and authorities, shall be paid an accommodation allowance of one hundred and eighty-six dollars (\$186) for each such night up to a maximum of twenty-five thousand one hundred and ten dollars (\$25,110) for each twelve month period commencing on and from 1 July 2008.

### **4. DATE OF OPERATION**

The allowances prescribed in Clause 2 and 3 of this Determination shall operate on and from 5 May 2008 unless otherwise prescribed in this Determination and supersede those prescribed previously in Determination No. 6 of 2006.

**ROAD TRAFFIC ACT 1961****NOTICE OF APPROVAL AND EXEMPTION**

*Pursuant to Sections 161A and 163AA of the Road Traffic Act 1961*

**OPERATION OF ROAD TRAIN VEHICLES IN SOUTH AUSTRALIA****1. REVOCATION OF PREVIOUS NOTICE AND OTHER EXEMPTION INSTRUMENTS**

- 1.1 I hereby revoke the Notice of Approval and Exemption, titled 'Operation of Road Train Vehicles in South Australia' published in the *South Australian Government Gazette* on 30 June 2005. This revocation will take effect from 12 a.m. on 2 June 2008.
- 1.2 I hereby revoke all Supplementary Notices of Approval, titled 'Operation of Road Train Vehicles in South Australia' as published in the *South Australian Government Gazette* that vary the conditions to and are read in conjunction with the Notice of Approval and Exemption identified in Clause 1.1 above. All Supplementary Notices of Approval will be revoked from 12 a.m. on 2 June 2008.

**2. DEFINITIONS**

- 2.1 For the purposes of this Notice:
- 2.1.1 A 'Road Train' is a vehicle combination consisting of a prime mover towing:
- a semi trailer and a converter dolly; or
  - two trailers, where a converter dolly supporting a semi trailer is counted as a single trailer (double road train); or
  - two trailers as described above (double road train) and an additional converter dolly (considered to be a triple road train); or
  - three trailers, where a converter dolly supporting a semi trailer is counted as a single trailer (triple road train).
- 2.1.2 'Approved Routes' are roads that the Minister for Transport (or the Minister's Delegate) has approved for the operation of Road Trains in accordance with section 161A of the *Road Traffic Act 1961*.
- 2.1.3 'DTEI' means the Department for Transport, Energy and Infrastructure.

**3. APPROVAL**

- 3.1 I hereby approve Road Trains to operate on Approved Routes subject to the conditions and limitations specified in this Notice.

**4. EXEMPTION**

- 4.1 I hereby exempt Road Trains from the following provisions of the:
- 4.1.1 *Road Traffic (Mass and Loading Requirements) Regulations 1999* Schedule 1, Table 1, in so far as it relates to:
- (i) tandem axle group fitted with dual tyres (8 tyres—for any vehicle other than a pig trailer 16.5 tonnes); and
  - (ii) triaxle group fitted with dual tyres (12 tyres—for any vehicle other than a pig trailer 20 tonnes); and
- 4.1.2 *Road Traffic (Vehicle Standards) Rules 1999* Rule 72 (1)—Height (4.3 metres).
- 4.1.3 *Road Traffic (Vehicle Standards) Rules 1999* Rule 169 (c)—Coupling Height.
- 4.1.4 *Road Traffic (Vehicle Standards) Rules 1999* Rule 66 (1)—Width (2.5 metres).
- 4.2 This exemption is subject to the conditions and limitations specified in this Notice.

**5. CONDITIONS AND LIMITATIONS APPLYING TO THIS NOTICE**

- 5.1 When you are operating under this Notice you must:
- 5.1.1 Operate at all times in accordance with the conditions and limitations specified in the 'Code of Practice for Road Trains', dated April 2008, issued by the DTEI.

- 5.1.2 Only travel on the Approved Routes for Road Trains as indicated in the maps specific to Road Trains or Converter Dollies (where the combination is being operated as a prime mover and semi trailer towing a converter dolly) posted on the DTEI Internet Site and in accordance with any conditions and limitations specified in those maps.
- 5.1.3 Carry at all times a legible, current and complete copy of:
- (i) this Notice;
  - (ii) the 'Code of Practice for Road Trains', dated April 2008;
  - (iii) all current approved Road Train and Converter Dolly route network map(s) (as appropriate) specific to the entire route being travelled/operated on during the particular journey being undertaken, including more specific detailed maps of routes and townships where available; and
  - (iv) a current driver medical certificate where you are required to undergo and pass a medical examination.
