*Riverbank Health and Entertainment Areas Development  
Plan Amendment Prepared by the Minister—  
For Public Consultation*

NOTICE is hereby given that the Minister for Planning, pursuant to Sections 24 and 26 of the Development Act 1993, has prepared a Riverbank Health and Entertainment Areas Development Plan Amendment (DPA) to amend the Adelaide (City) Development Plan.

The DPA complements the Greater Riverbank Implementation Plan (GRIP) released by Renewal SA on 30 June 2013 with the intended outcome of establishing a Development Plan policy framework that supports the staged implementation of the GRIP as it relates to the following areas:

- Entertainment Precinct—including the Adelaide Festival Centre, Convention Centre, the Adelaide Railway Station and Casino building and Parliament House and Old Parliament House.
- Health Precinct—which will consolidate uses around the new Royal Adelaide Hospital.

The DPA will be on public consultation from 17 July 2013 to 10 September 2013.
