## CONTROLLED SUBSTANCES ACT 1984

*Prohibition Order*

TAKE notice that on 1 November 2013, I, Dr Stephen Christley, Executive Director, Public Health and Clinical Systems, Department for Health and Ageing made an order under Section 57 (1) (c) of the Controlled Substances Act 1984. The order was served on Nicholas Lagos on 8 November 2013, and took effect on that date. Pursuant to Section 57 (3) of the Controlled Substances Act 1984, the Order is published as follows:

*Order Under Section 57 Controlled Substances Act 1984*

I, Dr Stephen Christley, Executive Director, Public Health and Clinical Systems, Department for Health and Ageing, having formed the opinion that Mr Nicholas Lagos has supplied a prescription drug in an irresponsible manner, hereby exercise the power delegated by the Minister for Mental Health and Substance Abuse under Section 62A of the Controlled Substances Act 1984 (SA), and make the following order under Section 57 (1) (c) of the Act:

is prohibited from supplying, administering or having possession of the following substances or class of substances;

- preparations containing pseudoephedrine.

This order does not apply to any of the above substances, drugs or class of drugs lawfully supplied or prescribed for the treatment of Nicholas Lagos by a registered health practitioner or by a veterinary surgeon for administration to an animal in Nicholas Lagos' care.

All other dimension limits specified in the *Road Traffic (Vehicle Standards) Rules 1999* must be met.

**4. CONDITIONS AND LIMITATIONS APPLYING TO THIS NOTICE**

This exemption is subject to the conditions and limitations specified in this notice.

When operating under this Notice you must comply with the following conditions:

- 4.1 When operating under this Notice, you must carry a legible, current and complete copy of this Notice either in hardcopy or in an electronic format so that it can be read from a device having a visual display (e.g. smart phone, tablet or laptop PC, in vehicle unit) that is carried within the vehicle and that is accessible, to a DPTI Authorised Officer appointed under the *Road Traffic Act 1961* or a Police Officer, from outside the vehicle.

  - 4.7.1 On the rear of the pole, one sight board displaying a vertical surface 750 millimetres long and 300 millimetres high to the sides and a vertical surface 400 millimetres square to the rear.
  - 4.7.2 Along the length of the pole, two sight boards each displaying a vertical surface of 350 millimetres long and 400 millimetres high to the sides
  - 4.7.3 All vertical surfaces of the sight boards to display 100 millimetres wide alternate red and yellow reflective stripes at an angle of 45 degrees.
  - 4.7.4 At night or during periods of low visibility the section of pole(s) that extends past the rear of the trailer must be delineated at the end with a red stop/tail light facing to the rear and side marker lights which display an amber light to the front and a red light to the rear. Side marker lights shall be spaced no greater than 2.0 metres apart.
  - 4.7.5 For the purpose of this notice 'a period of low visibility' means any time when, owing to insufficient day light or unfavourable conditions, persons or vehicles on a road are not clearly visible at a distance of 250 metres to a person of normal vision.

## Part 1—Preliminary

### 1—Short title

These regulations may be cited as the *Radiation Protection and Control (Non-Ionising Radiation) Regulations 2013*.

### 2—Commencement

These regulations will come into operation on 31 December 2014.

### 3—Interpretation

In these regulations, unless the contrary intention appears—

*Act* means the *Radiation Protection and Control Act 1982*;

*cosmetic tanning business* means a business consisting of or involving the provision of a cosmetic tanning service;

*cosmetic tanning service* means a service of tanning human skin for cosmetic purposes by use of a tanning unit;

*tanning unit* means electrically powered apparatus designed to produce tanning of human skin by exposure of the skin to ultraviolet radiation emitted by the apparatus;

*ultraviolet radiation* means radiation for which the wavelengths are within the range of 100 to 400 nanometres.

## **Part 2—Radiation protection and control**

### **Division 1—Licence to possess a radiation source**

#### **4—Licence to possess a radiation source**

For the purposes of section 33A(2)(b) of the Act, a thing that emits non-ionising radiation is prescribed.

### **Division 2—Prohibition on provision of commercial cosmetic tanning services**

#### **5—Offence to provide a commercial cosmetic tanning service**

A person must not, for fee or reward, or in the course of carrying on a business (whether or not for fee or reward), provide or offer to provide, a cosmetic tanning service to another person.

Maximum penalty: \$10 000.

#### **6—Requirement to keep documents and records**

- (1) A person who, before the commencement of these regulations, carried on a cosmetic tanning business must retain a copy of each written consent given by a person to whom a cosmetic tanning service was provided for at least 2 years from the date of the consent and keep it readily available for inspection by an authorised officer.

Maximum penalty: \$5 000.

- (2) The owner of a tanning unit must—

- (a) make a written record detailing any maintenance or servicing of the unit that took place while it was being used to provide a cosmetic tanning service for fee or reward; and
- (b) retain the record for at least 2 years; and
- (c) keep the record readily available for inspection by an authorised officer.

Maximum penalty: \$5 000.

- (3) If a person sells or otherwise disposes of a tanning unit that the person has used to provide a cosmetic tanning service for fee or reward, that person must—

- (a) make a written record of the date on which the unit was sold or otherwise disposed of and the name and address of the new owner of the unit; and
- (b) retain the record for at least 2 years after the sale; and
- (c) keep the record readily available for inspection by an authorised officer; and
- (d) give the new owner a copy of any records relating to the maintenance and servicing of the unit undertaken in the 2 years preceding the sale or other disposal.

Maximum penalty: \$5 000.

### **Part 1—Preliminary**

#### **1—Short title**

These regulations may be cited as the *Rates and Land Tax Remission Variation Regulations 2013*.

#### **2—Commencement**

The variation made to regulation 4(4) of the *Rates and Land Tax Remission Regulations 2009* by these regulations applies in relation to the 2013-2014 financial year and any subsequent financial year until a new percentage is prescribed.

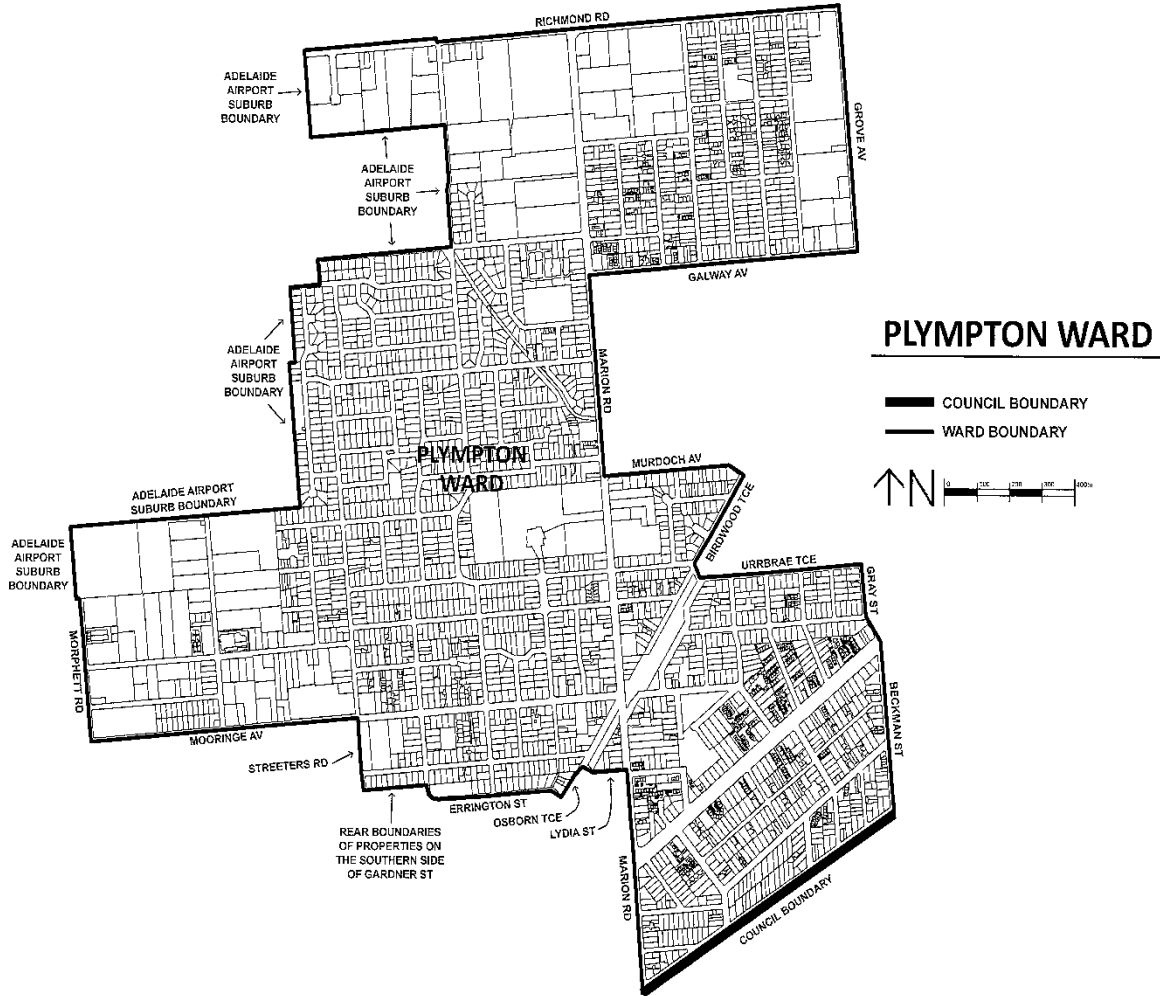

SCHEDULE ONE

Plympton Ward: Alter and adjust the boundaries of the existing Plympton Ward as follows:

Beginning at the corner of Richmond Road and Grove Avenue, which is the north-eastern corner of Plympton Ward, the boundary travels south along Grove Avenue, west along Galway Avenue, south along Marion Road, east along Murdoch Avenue, south-west along Birdwood Terrace, east along Urrbrae Terrace, south along Gray Street, and south along Beckman Street to the City of West Torrens Boundary. The boundary then follows the City of West Torrens Boundary south-west to Marion Road. The boundary then travels north along Marion Road, west along Lydia Street, south-west along Osborn Terrace, west along Errington Street until it reaches the rear boundary of properties on the south of Gardner Street where it heads west along the rear of those properties until it reaches Streeters Road. The boundary then travels north along Streeters Road, west along Mooringe Avenue, north along Morphett Road to the end of that road, where it follows the Airport Boundary at first to the north and then following the Airport Boundary until it reaches the end of Richmond Road. The boundary then continues east along Richmond Road, returning to Grove Avenue.

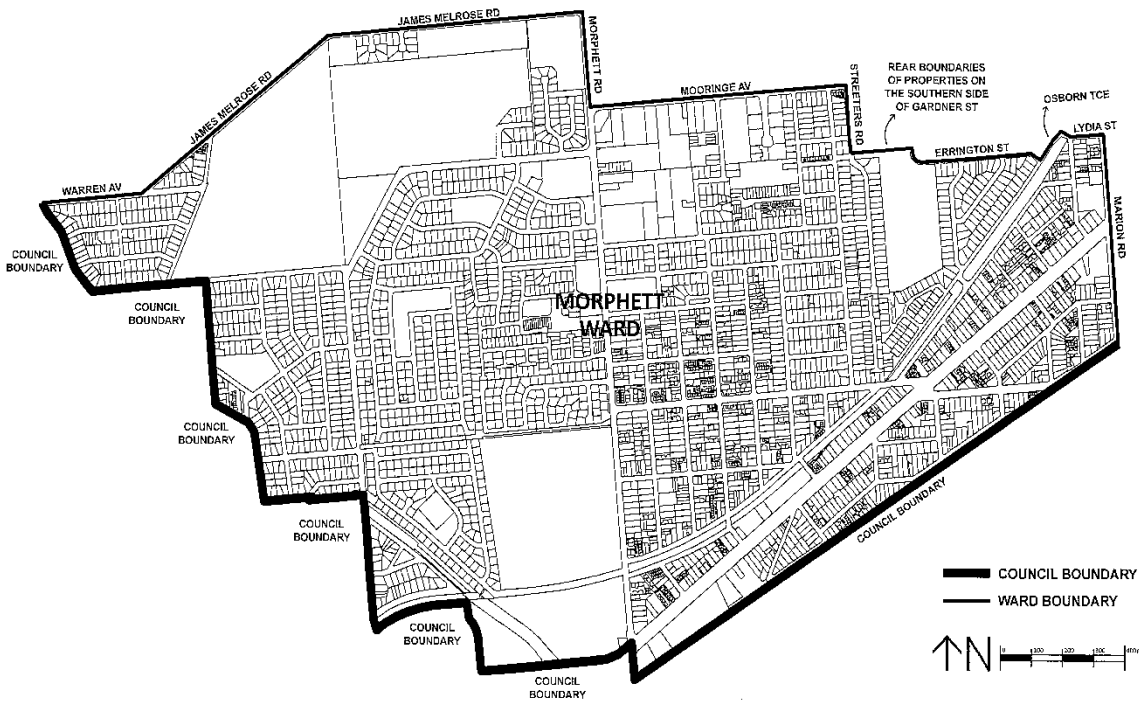

Keswick Ward: Alter and adjust the boundaries of the existing Keswick Ward as follows:

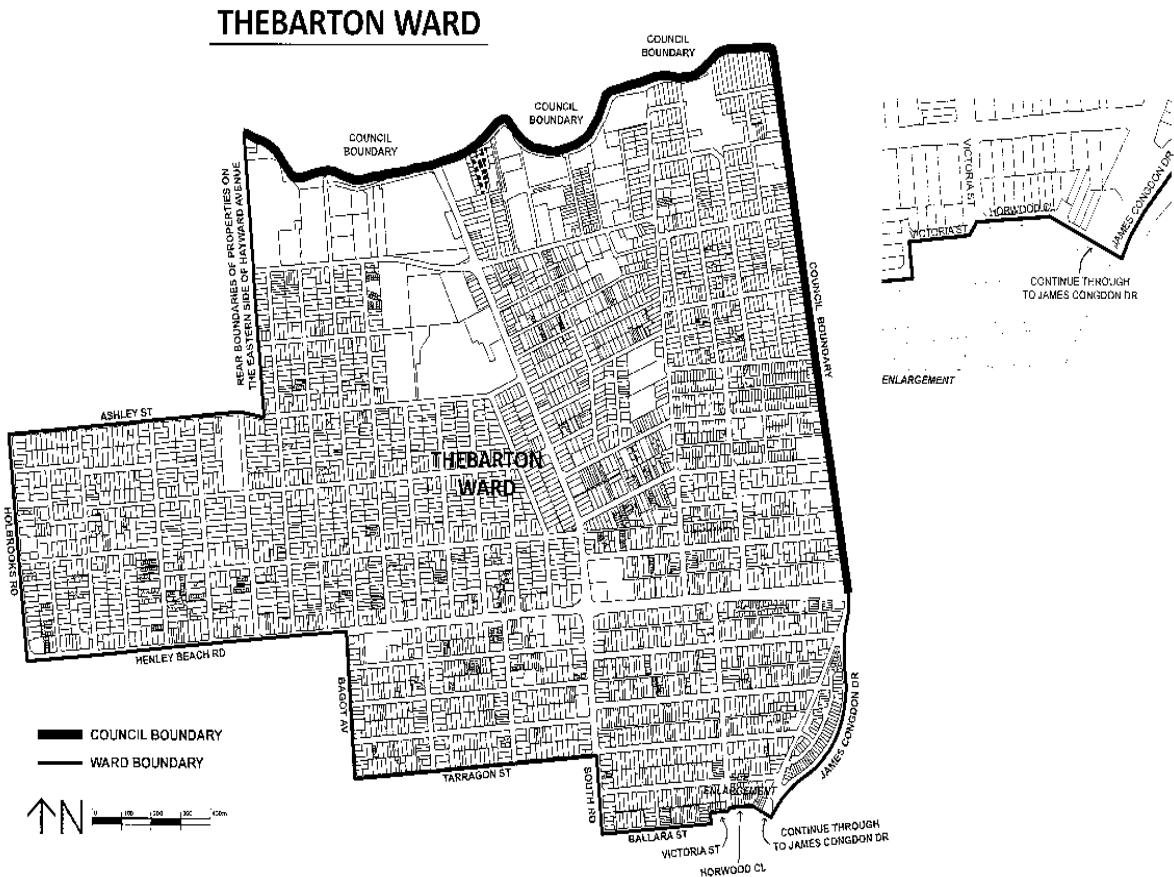

Thebarton Ward: Alter and adjust the boundaries of the existing Thebarton Ward as follows:

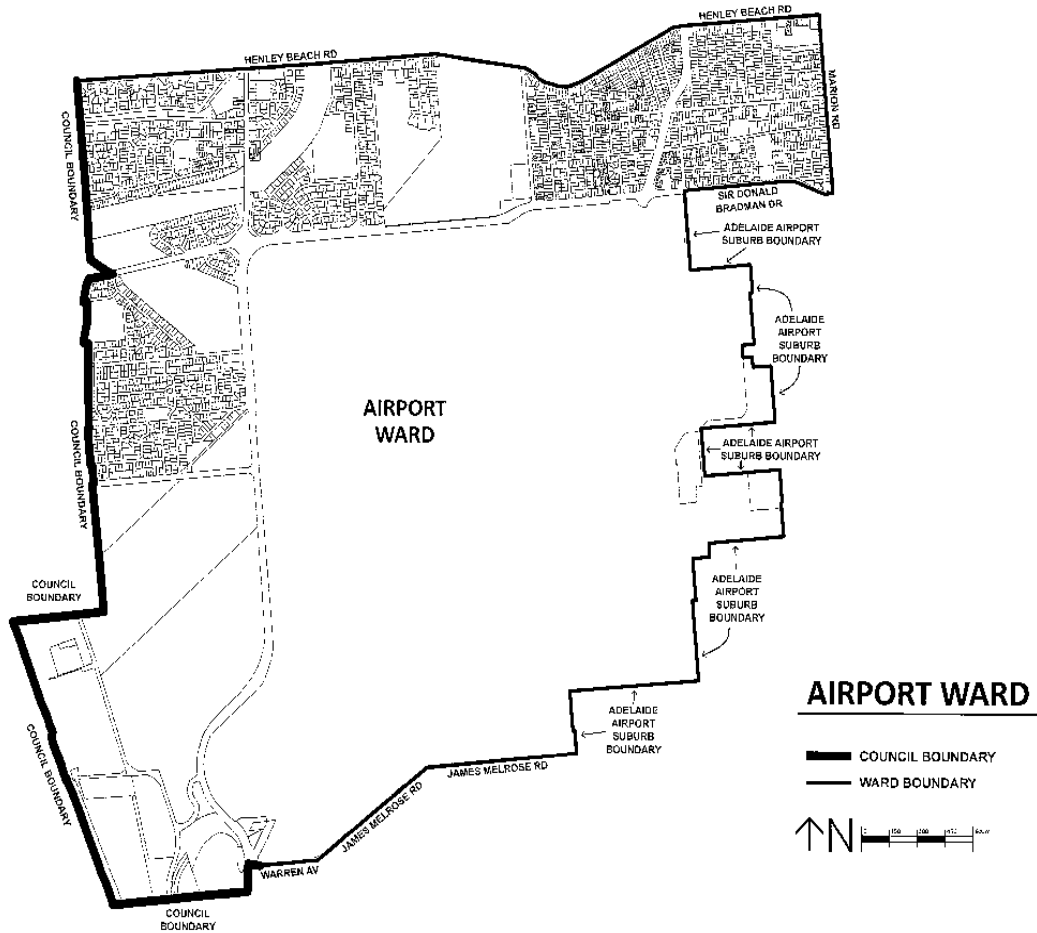
