### **Part 1—Preliminary**

#### **1—Short title**

These regulations may be cited as the *Passenger Transport (Point to Point Transport Services) Variation Regulations 2017*.

#### **2—Commencement**

These regulations come into operation on the day on which they are made.

#### **3—Variation provisions**

In these regulations, a provision under a heading referring to the variation of specified regulations varies the regulations so specified.

### **Part 2—Variation of *Passenger Transport Regulations 2009***

#### **4—Variation of regulation 3—Interpretation**

- (1) Regulation 3(1), definition of *chauffeured vehicle service*—delete the definition and substitute:
  - chauffeured vehicle service*—see regulation 3A;
- (2) Regulation 3(1), definition of *taxi service*—delete the definition and substitute:
  - taxi service*—see regulation 3A;

## 5—Insertion of regulation 3A

After regulation 3 insert:

### 3A—Definitions of chauffeured vehicle service and taxi service

For the purposes of section 4(1) of the Act and these regulations—

*chauffeured vehicle service* means a passenger transport service provided under a—

- (a) Small Passenger Vehicle (Metropolitan) Accreditation; or
- (b) Small Passenger Vehicle (Non-Metropolitan) Accreditation; or
- (c) Small Passenger Vehicle (Special Purpose) Accreditation; or
- (d) Small Passenger Vehicle (Traditional) Accreditation;

*taxi service* means a passenger transport service provided by use of a taxi.

#### Note—

As required by section 10AA(2) of the *Subordinate Legislation Act 1978*, the Minister has certified that, in the Minister's opinion, it is necessary or appropriate that these regulations come into operation as set out in these regulations.
