PARAFIELD AIRPORT LTD (PAL)  
*Schedule of Charges—Effective 1 July 2004*

THE prices shown in this schedule are inclusive of GST.

The following charges apply to the use of Parafield Airport:

(a) Landing Charge:

- (i) For each aircraft weighing more than 10 000 kg MTOW, a charge of \$6.04 per 1 000 kg MTOW pro-rata.
- (ii) For aircraft landing at Parafield Airport for the purposes of undergoing substantial maintenance on the airport and weighing less than 10 000 kg MTOW, a single charge of \$6.04 per 1 000 kg MTOW pro-rata.
- (iii) For the purposes of an aircraft undergoing substantial maintenance, evidence in the form of a Substantial Maintenance Claim Form must be submitted to the Credit Controller at Parafield Airport Ltd (PAL) within 24 hours of the aircraft landing at Parafield Airport. If PAL is not notified of an aircraft landing for substantial maintenance within 24 hours, then a daily charge of \$6.04 per 1 000 kg MTOW pro-rata will be levied in addition to the landing charge. It is the responsibility of the aircraft owner/operator to ensure that the form is lodged with PAL by the due date.

(b) General Aviation Access Charge (GAAC):

For each aircraft not covered by (a) above a GAAC of \$6.04 per 1 000 kg MTOW pro-rata per day or part of a day will be made.

GAAC may be paid in advance for periods of one month, six months or twelve months. Advance payment will attract a discount as shown in the table below.

1. *Special Conditions*

- 1.1 This Notice and the document titled 'Operation of Medium Combination Vehicles in South Australia', Edition 1 (clauses 1-6 and 8-10 only), issued by Transport SA or a legible copy of each shall be carried by the driver of the vehicle at all times when operating under this approval and exemption and be produced when requested by an Inspector appointed under the Road Traffic Act 1961 and/or Motor Vehicles Act 1959, or a Police Officer.
- 1.2 This Notice shall stand alone unless it is called up or referred to in any individual permit issued by Transport SA.
- 1.3 The vehicle is not under 'Notice of Suspension to Operate as a Medium Combination Vehicle' issued by the Minister for Transport.
- 1.4 When the B-Double is travelling along Main South Road between Cape Jervis and Delamere, the drive axle group of a tandem drive prime mover shall have a mass of not less than 14 tonnes when the B-Double is carrying a load of more than 10 tonnes.
- 1.5 After disembarking from the ferry at Cape Jervis, the B-Double must allow all other passenger vehicles disembarking from the ferry to proceed towards Myponga before the B-Double proceeds.

2. *Definitions*

For the purpose of this Notice the following definitions shall apply:

- 2.1 'B-Double' means a combination consisting of a prime mover towing 2 semi-trailers where the first semi-trailer is connected to the prime mover by a fifth wheel coupling and the second semi-trailer is connected to the first semi-trailer by a fifth wheel coupling.

  - (a) issued to a scheme member (whose accreditation status has not been suspended or cancelled); and
  - (b) that is legible and displayed on the nominated vehicle (owned or captured by the operator), for which the label was originally issued by the accrediting authority.

3. *General Conditions*

- 3.1 The vehicles defined herein are operated in accordance with the conditions specified in the document titled 'Operation of Medium Combination Vehicles in South Australia' Edition 1, (clauses 1-6, 8-10 only) issued by Transport SA and as amended by this Notice.
- 3.2 Where a B-Double is carrying dangerous goods on the Adelaide-Crafers Highway the vehicle combination shall be fitted with an approved anti-lock brake system in accordance with Transport SA's specifications. Refer to Permit Information Bulletin titled 'B-Double Anti-lock Brake Systems'.

For the purposes of Maintenance Management Accreditation, 'TruckSafe' is no longer a Maintenance Management Scheme recognised by Transport South Australia.

5. *Registration Categories*

5.1 Vehicles operating under this Notice shall be registered in accordance with the Charge Codes shown in Table 1.

6. *Transport of Baled Wool*

6.1 Baled wool may be carried subject to the following conditions:

- 6.1.1 The baled wool shall not be loaded more than four layers high.
- 6.1.2 The maximum overall vehicle height including the baled wool shall not exceed 4.6m.
- 6.1.3 The overall width of all axles or axle groups of the vehicle carrying the load, excluding the front axle or axle group, when measured between two vertical parallel planes located at the outer extremities of the tyres, shall not be less than 2.1m.
- 6.1.4 Hauliers operating under provisions of this Notice should be aware that some bridges, signs, overhead wires, trees and signals may not provide sufficient clearance for the passage of a 4.6m high vehicle.

## Information Note

Persons operating under the provisions of this Notice are advised that some parts of the road system, bridges, signs, roadside furniture and vegetation may not provide sufficient clearance for the passage of a vehicle and load at the dimensions permitted by this notice.

Section 106 of the Road Traffic Act – *Damage to roads and works*, includes provisions concerning damage to roads, bridges and culverts, interference with roadside furniture and the obligations of persons causing such damage to notify the appropriate authority.

7. *Routes*

- 7.3 B-Doubles may only stop in parking bays showing a 'Truck Parking Area' sign for rest purposes or vehicle checks but not for assembly or disassembly purposes. The sign shall comply with Australian Standard AS 1742.6 service symbol sign S13. The signs display a white 'P' and symbolic articulated vehicle on a blue background.
- 7.4 Approval to operate B-Double Vehicles up to 25 metres in length in accordance with the route maps 'Medium Combination Vehicles Route Network' included in the document 'Operation of Medium Combination Vehicles in South Australia' Edition 1, issued by Transport SA, is revoked.

Commencement of this Notice

This Notice is valid from 8 July 2004 .

This exemption may be varied or revoked at any time by notice in writing.

## WATER RESOURCES ACT 1997

*Notice of Assessment of Quantity of Water Taken when Meter Readings are not used*

PURSUANT to section 126 of the Water Resources Act 1997, I, John David Hill, Minister for Environment and Conservation, hereby declare that the basis of assessment of water use rates and the method by which the assessment of water use where meter readings are not used or when water is taken without licence or authorisation will be as set out in Schedule 1.

## SCHEDULE 1

The basis of the assessment of water use will be the estimation of water requirements for a crop.

The method by which the estimation of water requirements for crops will be used is the methodology of Doorenbos and Pruitt (1977), as refined by Allen *et al.* (1998) and set out in the PIRSA Technical Report No. 263, second edition ('the Report'). Crop factors will be calculated from Kc (crop coefficient) values from Food and Agriculture Organisation of the United Nations, Rome Irrigation and Drainage Paper 56 (Allen, Pereira *et al.* 1998) ('FAO 56') and using site specific monthly Kp (pan coefficient) values and average monthly Kg values (bird guard coefficient) set out in the Report.

The methodology incorporates the use of Bureau of Meteorology evaporation data, the application of crop specific factors to evaporation figures to calculate crop evapotranspiration for the crop and location in question, subtraction of effective rainfall and an allowance for leaching for salinity control and irrigation efficiency.

The water requirement calculated by this method is expressed as depth of water required in millimetres for a particular crop grown over a particular season. Depth multiplied by the number of hectares of that crop grown (in each specified season for short season crops), multiplied by 10 gives the volume of water required for each crop in kilolitres.

A copy of each of the Report and FAO 56 is obtained through the GEO Science Library at the Department of Primary Industries and Resources South Australia. The reference number for the Report is ISBN No. 07308-4349-1 and the reference number for FAO 56 is Kinetica/Amicus No. 000020037000 or ISBN No. 92-5-104219-5.

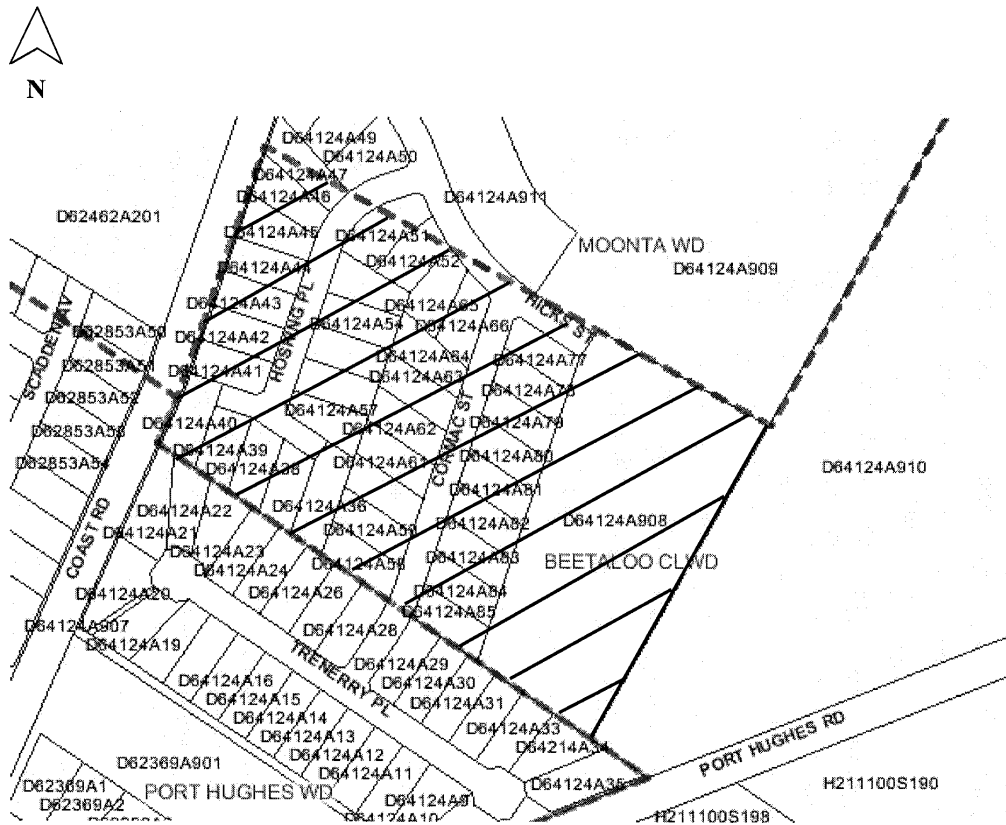

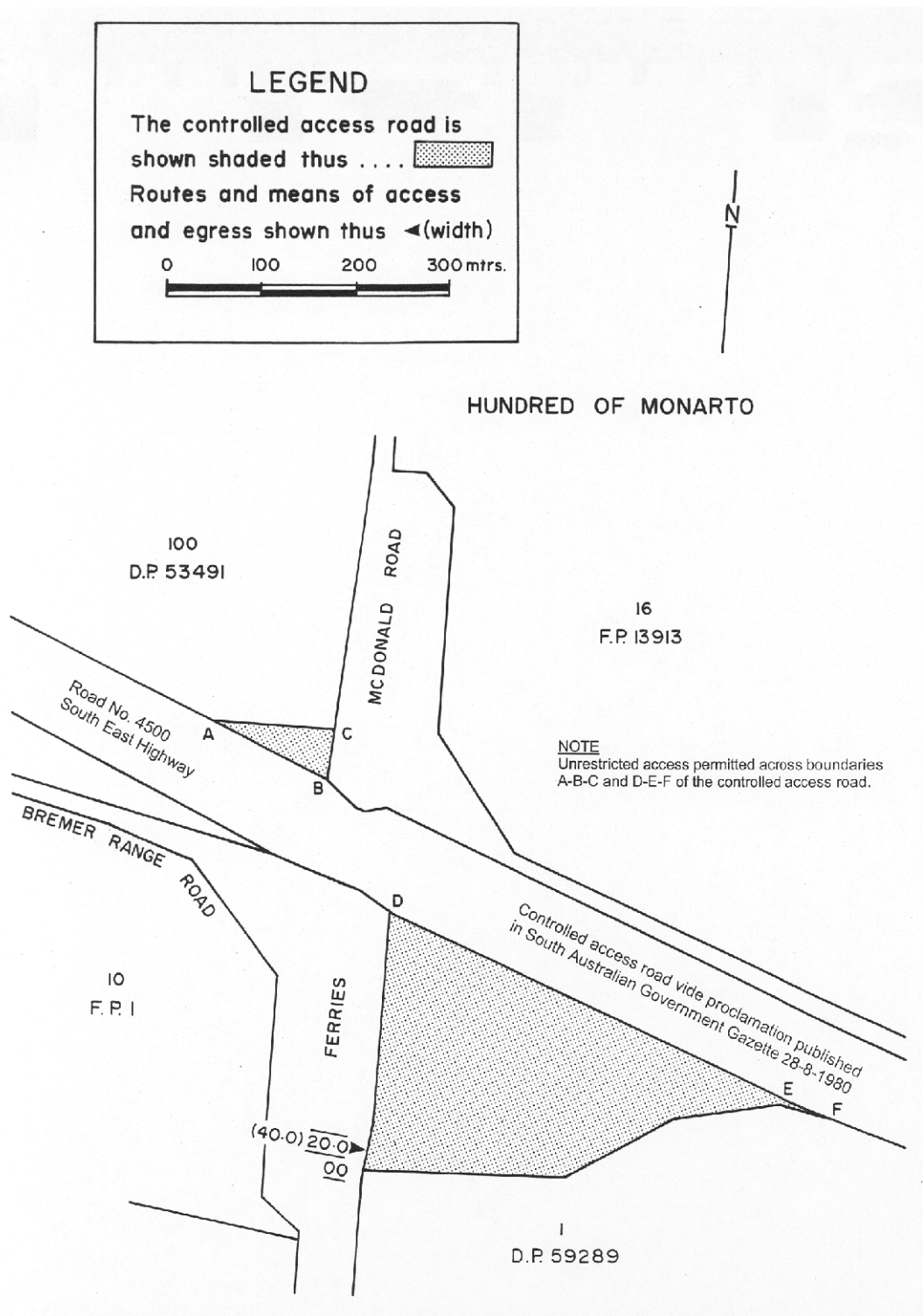

In order to carry out the activity of promoting and enhancing business viability, profitability and trade commerce and industry in that part of the council's area comprising the District Centre Zone in that part of the Development Plan applicable to the City of Glenelg (as it was prior to the amalgamation of the Cities of Glenelg and Brighton into the City of Holdfast Bay), declared a differential separate rate of 0.19785 cents in the dollar of the capital value of land on all rateable land in that zone of Categories 2, 3 and 4 use (such categories as set out in Regulation 10 (2) of the Local Government (General) Regulations 1999.

6. (a) In exercise of the powers contained in section 154 of the act and in order to carry out the activity to the maintenance and upkeep of the boat lock in the Patawalonga basin, a separate rate of 0.615 cents in the dollar of the capital value of land, be declared on all rateable land within the Patawalonga basin bounded by the high water mark.

(b) In exercise of the powers contained in section 158 of the act the amount that would otherwise be payable by way of rates in respect of this separate rate is altered by fixing the amount of rates payable for assessments that are wholly or partly within the part of the area on which this separate rate is imposed and the capital values of which exceed \$50 000 at \$350.

7. 3. *Minimum Rate*
