## FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, P. Tucker (hereinafter referred to as the 'permit holder'), from the Bookmark Biosphere Reserve, P.O. Box 955, Renmark, S.A. 5341 (or persons acting as her agents) are exempt from the provisions of the Fisheries Act 1982, insofar as the permit holder may engage in the taking of all aquatic organisms (hereinafter referred to as the 'permitted activity'), subject to the conditions set out in Schedule 1, using gear specified in Schedule 2, in the water specified in Schedule 3 from the date of gazettal of this notice until 30 June 2001.

## SCHEDULE 1

1. All fish including European Carp (*carpio carpius*) captured must be released immediately upon conclusion of scientific evaluation.

2. The specimens collected by the permit holder are for scientific and research purposes only and may not be sold.

3. The permit holder must provide the South Australian Research and Development Institute (SARDI) with details of all research information collected at the completion of each six month period during the term of this permit and on completion of the research project.

4. The permit holder shall not contravene or fail to comply with the Fisheries Act 1982 or any regulations made under that Act, except where specifically exempted by this notice.

5. While engaging in the permitted activity, the permit holder must be in possession of a copy of this notice. Such notice must be produced to a Fisheries Compliance Officer if such an officer requests that it be produced.

6. At least 24 hours prior to collecting any specimens pursuant to this notice, the permit holder must advise a Fisheries Compliance Officer of Primary Industries and Resources SA on 1800 065 522 with details of the proposed locations and the dates on which the permitted activity will be conducted.

## SCHEDULE 2

3 mesh nets (maximum length of each, 20 m).

1 seine net (maximum length 2 m, 2 mm mesh size, 1 m drop).

1 seine net (maximum length 20 m, 15 mm mesh size, 3m drop).

Hand dip nets.

Yabby/shrimp nets.

5 fyke nets (maximum outside diameter of band 115 cm, maximum length of 2 m, maximum wing length of 3 m).

## SCHEDULE 3

The following inland waters of South Australia:

- (1) Chowilla wetlands including Littra, Limbra, Werta Wert and Pilby Lagoons.
- (2) Calperum wetlands including Merriti, Clover and Woolpool Lagoons.
- (3) Little Duck Lagoon (Gurra floodplain).
- (4) Eckerts Creek wetland on Katarapko Island.
- (5) Loveday Complex at Cobdogla; and
- (6) Banrock wetland.

## FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Alan Payne (hereinafter referred to as the 'charter boat operator'), P.O. Box 98, Streaky Bay, S.A. 5680 is exempt from the provisions of Schedule 1 of the Scheme of Management (Marine Scalefish Fisheries) Regulations 1991, insofar as the charter boat operator may have non permitted species on board a boat registered on Marine Scalefish Fishery Licence No. M384 (hereinafter referred to as the 'permitted activity') subject to the conditions specified in Schedule 1.

## SCHEDULE 1

1. This exemption is valid from the date of gazettal of this notice until 30 June 1999.

2. When engaging in the permitted activity the charter boat operator shall cover or remove from the boat the commercial registration numbers.

3. The charter boat operator may only engage in the permitted activity whilst fee paying charter clients are on board the registered boat.

4. The charter boat operator must notify the compliance unit of PIRSA Fisheries and Aquaculture on 1800 065 522 (or the local fisheries office) prior to conducting any fishing operations pursuant to this notice.

5. The charter boat operator shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act except where specifically exempted by this notice.
