Township of Morgan

Pursuant to section 5 of the Local Government Act 1934, as amended, the Mid-Murray Council hereby defines the Township of Morgan as being comprising that portion of the Hundred of Eba as described in the proclamations of the Town of Morgan set out in the *South Australian Government Gazette* at various dates as described hereunder:

north-westerly and north-easterly along the boundary of the latter section to the south-eastern corner of section 464 thence north-westerly along the boundary of and the production north-westerly of the south-western boundary of section 464 to the River Murray and then generally south-westerly down the centre of the River Murray to the point of commencement, and as defined on Map No. MMC SR10.
