FISHERIES ACT 1982 : SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Neville Mattsson (hereinafter referred to as the 'exemption holder'), P.O. Box 261, Coffin Bay, S.A. 5607, holder of Marine Scalefish Fishery Licence No. M454, is exempt from section 41 of the Fisheries Act 1982, subject to the conditions in Schedule 1, but only insofar as the exemption holder shall not be guilty of an offence when using up to 100 crab pots for the taking of sand crabs (*Ovalipes australiensis*), rock crabs (*Nectocarcinus integrifrons*) and spider crabs (*Leptomithrax australiensis*) (hereinafter referred to as the 'permitted species') for the purpose of trade or business in coastal marine waters of South Australia (hereinafter referred to as the 'permitted activity') from the date of gazettal of this notice until 30 June 2001.

SCHEDULE 1

1. The exemption holder may only use a boat (hereinafter referred to as the 'permitted boat') registered on Marine Scalefish Fishery Licence No. M454 to conduct the permitted activity.
2. The exemption holder must be on board the permitted boat at all times whilst the permitted activity is being conducted.
3. The exemption holder shall not use any kind of device other than a crab pot for the purpose of engaging in the permitted activity which has attached a buoy that is constructed of material that is durable in water, has a volume of not less than 4 L, is of orange colour and is clearly marked with the registered number of the boat with letters and figures of not less than 7 cm in height.
4. Any fish, other than the permitted species, taken as by-catch by the exemption holder during the permitted activity must be immediately returned to the water.
5. The exemption holder must complete a monthly return within 14 days of the end of the previous month and forward it to the South Australian Research and Development Institute, P.O. Box 120, Henley Beach, S.A. 5022. This return must be completed regardless of whether the exemption holder took fish or not (nil returns are required).

6. While engaged in the permitted activity the exemption holder must have in his possession a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries Compliance Officer.

7. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that Peter Maxwell Doley (hereinafter referred to as the 'exemption holder'), 20 Kohinoor Road, Kingscote, S.A. 5223, holder of Marine Scalefish Fishery Licence No. M117, is exempt from the provisions of section 41 of the Fisheries Act 1982 but only insofar as the exemption holder shall not be guilty of an offence when taking undersized fish of the species cockles (*Katylsia spp.*), subject to the conditions specified in Schedule 1, from the date of gazettal of this notice until 30 June 2001.

SCHEDULE 1

1. The exemption holder may engage in the following fishing activity (hereinafter referred to as the 'exempted activity') namely the taking of undersized fish as specified in Schedule 2, within those waters specified in Schedule 3.
2. Any fish taken by the exemption holder pursuant to this notice must be used for bait only and must not be sold.
3. While engaged in the exempted activity, the exemption holder shall carry or have about or near his person, a copy of this notice. Such notice must be produced to a PIRSA Fisheries Compliance Officer upon request.

4. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulation made under that Act, except where specifically exempted by this notice.

SCHEDULE 2

Cockles (*Katelysia spp.*) not less than 27 mm in length.

SCHEDULE 3

The waters in the vicinity of Kingscote bounded as follows: commencing at a point at high water mark at Cape Rouge, latitude 35°35'52"S, and longitude 137°37'32"E, then along the geodesic (190°T), to a point at high water mark on the south coast on the Bay of Shoals, latitude 35°38'18"S, and longitude 137°37'05"E, then following the line of high water mark in a generally easterly and southerly direction to a point at high water mark at the landward end of the Kingscote jetty, latitude 35°39'15"S and longitude 137°38'32"E, then along the geodesic (133°T) for a distance of 2.3 nautical miles to position latitude 35°40'32"S longitude 137°41'00"E, then along the geodesic (033°T) for a distance of 2.1 nautical miles to a position latitude 35°38'50"S longitude 137°42'15"E, then along the geodesic (325°T) to a point at high water mark on Marsden Point, latitude 35°33'55"S and longitude 137°38'07"E, then following the line of high water mark in a generally southerly direction back to the point of commencement.
