FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Thierry Laperousaz and Greg Rouse from the Division of Natural Science, South Australian Museum, North Terrace, Adelaide, S.A. 5000 (the 'exemption holders') or a person acting as their agent, are exempt from the provisions of the Fisheries (Aquatic Reserves) Regulations 1989 and clauses 1, 48 and 65 of Schedule 1 of the Fisheries (General) Regulations 2000, but only insofar as the exemption holders may collect marine organisms from South Australian coastal waters including intertidal 'rocky' reefs using the gear specified in Schedule 1 or by using chemical anaesthetics (the 'exempted activity'), subject to the conditions set out in Schedule 2, from the date of gazettal of this notice until 30 June 2005, unless varied or revoked earlier.

SCHEDULE 2

1. The specimens collected by the exemption holders are to be used for scientific purposes only and must not be sold.

2. Before conducting the exempted activity, the exemption holders must contact the PIRSA Fisheries Compliance Unit on 1800 065 522 and answer a series of questions about the exempted activity. You will need to have a copy of your exemption with you at the time of making the call, and be able to provide information about the area and time of the exempted activity, the vehicles and/or boats involved, the number of agents undertaking the exempted activity and other related issues.

3. While engaged in the exempted activity, the exemption holders and their agents must be in possession of a copy of this notice. Such notice must be produced to a PIRSA Fisheries Officer if requested.

4. The exemption holders must not contravene or fail to comply with the Fisheries Act 1982 or any regulations made under that Act, except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Chris Burgess (the 'exemption holder'), 12 James Street, Salisbury, S.A. 5108 is exempt from section 50 of the Fisheries Act 1982, but only insofar as the exemption holder may introduce flathead, gudgeon, common galaxias, small mouthed hardy head blue-spot goby native species (the 'exempted activity') for the purposes of restocking the wetlands listed in Schedule 1 from the catchments specified in Schedule 2 subject to the conditions set out in Schedule 3 from the date of gazettal of this notice until 30 June 2005, unless varied or revoked earlier.

SCHEDULE 3

1. Before conducting the exempted activity, the exemption holder must contact the PIRSA Fisheries Compliance Unit on 1800 065 522 and answer a series of questions about the exempted activity. You will need to have a copy of your exemption with you at the time of making the call, and be able to provide information about the area and time of the exempted activity, the vehicles and/or boats involved, the number of agents undertaking the exempted activity and other related issues.

2. The exemption holder may use one agent to assist him with the exempted activity, provided that agent operates from the same vessel as the exemption holder.

3. While engaged in the exempted activity the exemption holder must have in their possession a copy of this notice and such a notice must be produced to a PIRSA Fisheries Compliance Officer if requested.

4. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act or any condition of this notice, except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Antony Smith (the 'exemption holder'), P.O. Box 1375, Berri, S.A. 5343, is exempt from section 34 of the Fisheries Act 1982, but only insofar as the exemption holder may take European carp, goldfish, redbfin and other non-native species for the purposes of trade or business by the use of gill nets (the 'exempted activity') from the waters listed in Schedule 1, subject to the conditions set out in Schedule 2 from the date of gazettal of this notice until 30 June 2005, unless varied or revoked earlier.

SCHEDULE 2

1. All fish caught, except non-native species must be immediately returned to the water unharmed.

2. Before conducting the exempted activity, the exemption holder must contact the PIRSA Fisheries Compliance Unit on 1800 065 522 and answer a series of questions about the exempted activity. You will need to have a copy of your exemption with you at the time of making the call, and be able to provide information about the area and time of the exempted activity, the vehicles and/or boats involved, the number of agents undertaking the exempted activity and other related issues.

3. The exemption holder may use one agent to assist him with the exempted activity, provided that agent operates from the same vessel as the exemption holder.

4. All fish transported for sale must be transported in bins clearly marked with the number R54 and the name, Antony (or Tony) Smith.

5. While engaged in the exempted activity the exemption holder must have in his possession a copy of this notice and such a notice must be produced to a PIRSA Fisheries Compliance Officer if requested.

6. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act or any condition of this notice, except where specifically exempted by this notice.
