### Amendment No. 21 to the Magistrates Court (Civil) Rules 1992

PURSUANT to section 49 of the Magistrates Court Act 1991 and all other enabling powers, we the undersigned do make the following amendments to the Magistrates Court (Civil) Rules 1992:

Rule 106 is deleted and replaced with the following:

106. (1) Subject to these Rules or to an order of the Court, a successful party in an action (other than a minor civil action) is entitled on judgment to costs against an unsuccessful party, or any other party that the Court may order, in accordance with the following principles:
- (a) where judgment is in respect of an action for a sum of money:
    - (i) a successful plaintiff is entitled to costs on the relevant scale in the Third Schedule applicable to the sum actually recovered;
    - (ii) a successful defendant is entitled to costs on the relevant scale in the Third Schedule applicable to the sum claimed;
  - (b) where judgment is in respect of any other action—a successful party is entitled to costs on the scale in the Third Schedule specified by the Court;
- or
- (c) where the action involved unusual difficulty or intricacy, or other proper cause exists—a successful party is entitled to costs on such percentage of the Supreme Court scale as the Court specifies.
- (2) In a minor civil action, a successful party is entitled on judgment to costs against an unsuccessful party, or any other party that the Court may order, in accordance with the relevant scale in the Third Schedule.
- (3) If, on the hearing of an action (other than a minor civil action), a successful party recovers a sum of money being \$3 000 or less, that party is, unless for special reasons the Court orders otherwise, entitled to costs only as if it were a minor civil action.
- (4) Where proper cause exists, the Court may order that a successful party is entitled to costs on a solicitor and client basis.
- (5) Unless the Court orders otherwise, a party is not entitled to costs on both a claim and counterclaim in the same action.
- (6) Where there is no scale of costs applicable to an action or proceeding, the Court may fix the appropriate scale of costs on application of the successful party or at the request of the Registrar.
- (7) (a) A party may, by notice in writing served on all other parties, certify that the nature of an action entitles the parties to costs on the relevant scale in the Third Schedule as a complex action and, unless any other party by notice in writing objects (including detailed reasons for the objection) within 21 days of the service of the notice, a party entitled to costs in the action is entitled to costs on the relevant scale as a complex action.

- (b) If a party so objects, the relevant scale may be determined by the judicial officer hearing the trial of the action.
- (c) In any other case, unless the Court orders otherwise, the relevant scale for a complex action will not apply.
- (8) A plaintiff who serves a claim by post (except by the agency of the Registrar) is not entitled to the costs thrown away up to the time a judgment relying upon that service is set aside unless the Court is satisfied that the claim form came to the attention of the defendant.
- (9) Where a Non-Payment Order is in force Rule 127A deals with a creditor's right to costs.
- (10) A magistrate may intimate her or his view of the likely result of a case at any time in pre-trial processes and if s/he does so that intimation must not be available to the trial magistrate until after judgment when the trial magistrate may take it into account in relation to costs.

Note that a plaintiff may not be entitled to the costs for the filing of a claim unless notice of the claim is given, or if the defendant has given notice of willingness to consent to judgment, in accordance with Rule 20A.

- (6) it must be signed by Luke Andrew Christofis; and
- (7) it must be signed by the radiographer who is performing the examination or treatment.

3. Luke Andrew Christofis must, when directed to do so by the Radiation Protection Division, provide the Radiation Protection Division with a written report on diagnostic radiography authorised by him during a period specified by the Radiation Protection Division. The report must contain statistics of diagnostic radiography authorised and details of any radiation safety issues associated with the examinations during the specified period.

Taxation receipts for the first three months of 2003-04 were higher than for the same period in the previous year mainly on account of the continuing strength in the property market, which is reflected in stamp duties (mainly mortgages and property transfers) and underlying strength in economic conditions impacting on payroll tax receipts.

The tax comparison between years is also affected by timing differences which artificially depressed receipts in the September quarter of 2002.

Gambling tax revenues were significantly understated in the September quarter 2002 as a result of the late processing of revenue collections to the Consolidated Account by the Department of Justice. This gives the misleading appearance of considerable revenue gains in 2003-04.

The higher level of collections of Commonwealth Places Mirror Taxes in 2003-04 reflects the underlying increase in stamp duty and payroll tax collections.

***Fees and charges***

The higher level of fees and charges revenue for the September quarter 2003 reflects the timing of receipts in 2002 from the South Australian Housing Trust and the South Australian Police Department. Some revenue collected in the September quarter 2002 for these Agencies was not recorded until the following quarter.

***Royalties***

The apparent increase in royalty revenue between September quarters 2002 and 2003 is also affected by timing differences. Delays in royalty payments by SANTOS and Western Mining Corporation depressed royalty revenue in the September quarter 2002. Adjusting for this effect, royalty revenue for the September quarter is broadly comparable between 2002 and 2003.

***Commonwealth – General Purpose Grants***

The lower level of general purpose revenue from the Commonwealth in the September quarter 2003 reflects the recovery by the Commonwealth of overpayments of transitional assistance in 2002-03.

### *Commonwealth – Specific Purpose Grants*

The lower level of Commonwealth Specific Purpose Grants in the September quarter 2003 reflects the cessation on 30 June 2002 of the temporary additional First Home Owner Grant (FHOG) available to first homebuyers building a new home or purchasing a previously unoccupied new home. These temporary grants were funded through specific purpose grants.

### *Payments*

Payments have been made pursuant to the *Appropriation Act*, passed at the time of the 2003-04 State Budget and in accordance with various Acts for which specific appropriation has been authorised.

The total payments for the three months ending 30 September 2003 are broadly in line with the budget for the 2003-04 financial year.

The structure of the *Appropriation Act* was changed in the 2003-04 Budget to provide a greater number of appropriation lines and to reflect changes in administrative structures. Accordingly, comparative data are not available for all payments made from the Consolidated Account for the September quarter 2003 relative to the September quarter 2002. Footnotes to the Statement of Payments indicate the agencies affected by these changes.

### *Note*

Considerable caution should be exercised in interpreting the quarterly statement of Consolidated Account transactions. Unlike the State budget, the information is purely limited to cash transactions. In addition, the Consolidated Account does not capture all the transactions undertaken by the general government sector (in particular, it does not record receipts and payments from special deposit accounts). Finally, it should be noted that the timing of receipts and payments could be volatile within a particular year. As a result, apparently significant movements between years may only be due to changes in the timing of receipts and payments, and therefore may not have implications for the underlying budget position.
