*South Australia—River Murray—Murray Mouth Dredging*

## Former Notice to Mariners No. 41 of 2016

MARINERS are advised that dredging works will commence at the River Murray mouth on Monday, 9 January 2017. This work will be undertaken at the River Murray mouth, within the Coorong National Park; on the west by a north-south line passing through Beacon 2 across the Goolwa Channel, and on the east by a line due north commencing at a point 35.559926°S 138.898474°E (Barkers Knoll) across the Coorong Channel and on the seaward side of the Sir Richard and Younghusband Peninsulas, 1.5 km either side of the river mouth, and 100 m seaward from the high water mark.

This work will be continuous, day and night and dredgers will display the appropriate lights and shapes as prescribed by the River Murray Traffic Regulations.

Boating traffic through the area will be permitted during daylight hours where safety is not compromised. Temporary closure of the channel may be required from time to time.

The Court orders that:

1. The Defendant is prohibited from instituting further proceedings in a prescribed court within the meaning of Section 39 of the Supreme Court Act 1935 (SA) without the permission of the Supreme Court.

2. All existing proceedings which have been instituted by the Defendant in a prescribed court within the meaning of Section 39 of the Supreme Court Act 1935 (SA) are stayed under Section 39 (1) (b) of the Supreme Court Act 1935 (SA) except the Defendant's appeal dated 21 May 2012 in respect of:

(a) orders 2, 3, 5, 9, 10 and 11; and

(b) order 4 in respect only of files 2842 of 2004, 2845 of 2004, 2847 of 2004, 2853 of 2004, 2855 of 2004, 2860 of 2004, 2861 of 2004 and 2238 of 2005, made by Olsson, A.J. on 26 July 2012, in consolidated file 680 of 2003.

3. Liberty to the Defendant to apply to lift the stay the subject of order 2 in respect of any proceedings other than his application filed in January 2012 in the Workers Compensation Tribunal in matter 7089 of 1999, his application filed in May 2012 in the Workers Compensation Appeal Tribunal in matters 0542 of 1995, 22W of 1997, 65W of 1997, 4711 of 2003 and 4719 of 2003; and his appeal filed in May 2012 in the Workers Compensation Tribunal against the judgement of Olsson, A. J. in consolidated file 680 of 2003.

4. The Defendant is to pay 90 percent of the plaintiff's costs of the action to be adjudicated.

## ENVIRONMENT PROTECTION ACT 1993

*Approval of Category B Containers*

I, ANDREA KAYE WOODS, Team Leader, Container Deposit Legislation and Delegate of the Environment Protection Authority ('the Authority'), pursuant to Section 68 of the Environment Protection Act 1993 (SA) ('the Act') hereby:

*Approval of Category B Containers*

Approve as Category B Containers, subject to the conditions in subclauses (1), (2), (3) and (4) below, each of the classes of containers identified by reference to the following matters described in the first 4 columns of Schedule 1 of this Notice which are sold in South Australia:

- (a) the product which each class of containers shall contain;
  - (b) the size of the containers;
  - (c) the type of containers; and
  - (d) the name of the holders of these approvals.
- (1) That containers of the class to which the approval relates must bear the refund marking specified by the Authority for containers of that class. The Authority specifies the following refund markings for Category B containers:
    - (i) '10c refund at collection depots when sold in SA'; or
    - (ii) '10c refund at SA/NT collection depots in State/Territory of purchase'.
  - (2) The holder of the approval must have in place an effective and appropriate waste management arrangement in relation to containers of that class. For the purpose of this approval notice the company named in Column 5 of Schedule 1 of this Notice is the nominated super collector.
  - (3) In the case of an approval in relation to category B containers that the waste management arrangement must require the holder of the approval to provide specified super collectors with a declaration in the form determined by the Authority in relation to each sale of such containers by the holder of the approval as soon as practicable after the sale.
  - (4) The holder of these approvals must ensure that if a sticker bearing the refund marking has been approved and is applied to the container, then the sticker must not be placed on any portion of the opening mechanism or in any other place that would require complete or partial removal of the sticker before the contents may be consumed.

These approvals are revoked as the Authority is satisfied that the waste management arrangement between the approval holder and the party named in Column 5 of Schedule 1 of this Notice has been cancelled.

BY-LAW MADE UNDER THE LOCAL GOVERNMENT ACT 1999  
*Permits and Penalties By-law 2016*  
*By-law No. 1 of 2016*

A by-law to provide for and regulate permits and penalties issued by the Council.

PART 1—PRELIMINARY

1. *Title*

This by-law may be cited as the Permits and Penalties By-law 2016.

2. *Objectives*

The objectives of this by-law are to provide for the good rule and government of the Council area and for the convenience, comfort and safety of its community by providing for:

- 2.1 the issuing of permits under Council by-laws; and
- 2.2 the imposition of penalties for breaches of Council by-laws.

3. *Commencement*

- 3.1 The Council's Permits and Penalties By-law 2010 is revoked from the day on which this by-law comes into operation.
- 3.2 This by-law comes into operation on 1 July 2017.

4. *Application*

This by-law applies throughout the Council area.

5. *Interpretation*

- 5.1 In this by-law, unless the contrary intention appears:
  - 5.1.1 *Act* means the Local Government Act 1999;
  - 5.1.2 *Council* means the Rural City of Murray Bridge;
  - 5.1.3 *person* includes a natural person, a body corporate and an unincorporated association.
- 5.2 This by-law is to be interpreted as being subject to the Act, other Acts and the general law of South Australia.

PART 2—PERMITS AND PENALTIES

6. *Permits*

- 6.1 In any by-law of the Council, unless the contrary intention appears permission means permission of the Council, granted in writing prior to the act, event or activity to which it relates.
- 6.2 Where a by-law requires that permission be obtained, any person seeking the grant of permission must submit a written application to the Council in the form (if any) and accompanied by the fee (if any) prescribed by the Council.
- 6.3 The Council may attach such conditions as it thinks fit to a grant of permission and may vary or revoke such conditions or impose new conditions by notice in writing to the person granted permission.
- 6.4 A person granted permission must comply with every condition applying to the permission.
- 6.5 The Council may suspend or revoke a grant of permission at any time by notice in writing to the person granted permission.

7. *Offences and Penalties*

- 7.1 A person who commits a breach of any by-law of the Council is guilty of an offence.
- 7.2 The maximum penalty specified by Section 246 (3) (g) of the Act for the breach of a by-law applies to any breach of a by-law of the Council.
- 7.3 Where a breach of a by-law of the Council continues, the maximum penalty specified by Section 246 (3) (g) of the Act for a continuing offence applies to any breach of a by-law of the Council which continues.
- 7.4 The expiation fee for a breach of a by-law is a fee equivalent to 25 percent of the maximum fine applicable to a breach of the by-law.

This by-law was duly made and passed at a meeting of the Council held on 12 December 2016 by an absolute majority of the members for the time being constituting the Council, there being at least two-thirds of the members present.

RURAL CITY OF MURRAY BRIDGE  
BY-LAW MADE UNDER THE LOCAL GOVERNMENT ACT 1999  
*Local Government Land By-law 2016*  
*By-law No. 2 of 2016*

A by-law to regulate access to and use of local government land (other than roads).

PART 1—PRELIMINARY

1. *Title*

This by-law may be cited as the Local Government Land By-law 2016.

2. *Objectives*

The objectives of this by-law are to regulate the access to and use of local government land (other than roads):

- 2.1 to prevent and mitigate nuisances;
- 2.2 to prevent damage to local government land;
- 2.3 to protect the convenience, comfort and safety of members of the public;
- 2.4 to enhance the amenity of the Council area; and
- 2.5 for the good rule and government of the Council area.

3. *Commencement*

- 3.1 The Council's Local Government Land By-law 2010 is revoked from the day on which this by-law comes into operation.
- 3.2 This by-law comes into operation on 1 July 2017.

4. *Application*

- 4.1 The Council's Permits and Penalties By-law 2016 operates in respect of:
  - 4.1.1 permissions required by or given under this by-law; and
  - 4.1.2 penalties for breach of this by-law.
- 4.2 Subject to Clauses 4.3, 4.4 and 4.5, this by-law applies throughout the Council area.
- 4.3 Clauses 7.3, 7.10.1, 7.10.5, 7.25.3, 8.3 and 8.10.3 of this by-law only apply in such part or parts of the Council area as the Council may determine in accordance with Section 246 (3) (e) of the Act.
- 4.4 This by-law does not apply to a police officer, emergency worker, Council officer or employee acting in the course and within the scope of that person's normal duties, or to a contractor while performing work for the Council and while acting under the supervision of a Council officer.
- 4.5 Clauses 7.1, 7.8, 7.17 and 7.30 of this by-law do not apply to electoral matters authorised by a candidate and which is related to:
  - 4.5.1 a Commonwealth or State election and occurs during the period commencing on the issue of the writ or writs for the election and ending at the close of polls on polling day;
  - 4.5.2 an election under the Act or the Local Government (Elections) Act 1999 and occurs during the period commencing four weeks immediately before the date that has been set (either by or under either Act) for polling day and ending at the close of voting on polling day; or
  - 4.5.3 occurs during the course of and for the purpose of a referendum or poll.

5. *Interpretation*

- 5.1 In this by-law, unless the contrary intention appears:
  - 5.1.1 *Act* means the Local Government Act 1999;

- 5.1.2 *animal* includes birds, insects and poultry but does not include a dog;
- 5.1.3 *boat* includes a raft, pontoon, houseboat, personal watercraft or other similar device;
- 5.1.4 *camp* includes setting up a camp, or causing a tent, caravan or motor home to remain on the land for the purpose of staying overnight, whether or not any person is in attendance or sleeps on the land;
- 5.1.5 *children's playground* means an enclosed area in which there is equipment or other devices installed for the purpose of children's play (or within 3 metres of such devices if there is no enclosed area);
- 5.1.6 *Council* means the Rural City of Murray Bridge;
- 5.1.7 *electoral matter* has the same meaning as in the Electoral Act 1985 provided that such electoral matter is not capable of causing physical damage or injury to any person within its immediate vicinity;
- 5.1.8 *effective control* means a person exercising effective control of an animal either:
- (a) by means of a physical restraint; or
- (b) by command, the animal being in close proximity to the person and the person being able to see the animal at all times;
- 5.1.9 *emergency worker* has the same meaning as in the Road Traffic (Road Rules—Ancillary and Miscellaneous Provisions) Regulations 2014;
- 5.1.10 *foreshore* means land extending from the edge of any navigable waterway or body of water in the Council's area to the nearest road or section boundary or for a distance of 50 metres (whichever is the lesser);
- 5.1.11 *funeral ceremony* means a memorial service not including a burial;
- 5.1.12 *liquor* has the same meaning as in the Liquor Licensing Act 1997;
- 5.1.13 *local government land* means all land owned by the Council or under the Council's care, control and management, except roads;
- 5.1.14 *offensive* includes threatening, abusive, insulting or annoying behaviour and offend has a complementary meaning;
- 5.1.15 *tobacco product* has the same meaning as in the Tobacco Products Regulation Act 1997;
- 5.1.16 *vehicle* has the same meaning as in the Road Traffic Act 1961; and
- 5.1.17 *waters* includes a body of water, including a pond, lake, river, creek or wetlands under the care, control and management of the Council.
- 5.2 This by-law is to be interpreted as being subject to the Act, other Acts and the general law of South Australia.
- PART 2—ACCESS TO LOCAL GOVERNMENT LAND**
6. *Access*
- A person must not without permission, enter or remain on any local government land:
- 6.1 where entry fees or charges are payable, without paying those fees or charges; or
- 6.2 where the land has been enclosed by fences and/or walls and gates that have been closed and locked.
- PART 3—USE OF LOCAL GOVERNMENT LAND**
7. *Activities Requiring Permission*
- A person must not, without the permission of the Council, do any of the following on local government land:
- 7.1 *Advertising*
- Subject to Clause 4.5, display, paint or erect any sign or hoarding for the purpose of commercial advertising or any other purpose other than in accordance with the Council's Moveable Signs By-law 2016.
- 7.2 *Aircraft*
- Subject to the Civil Aviation Act 1988 (Cth), land any aircraft on, or take off any aircraft from the land.
- 7.3 *Alcohol*
- Consume, carry or be in possession or in charge of any liquor on local government land comprising parks or reserves to which the Council has determined this Clause applies.
- 7.4 *Amplification*
- Use an amplifier or other mechanical or electrical device for the purpose of broadcasting sound, or magnifying sound.
- 7.5 *Animals*
- 7.5.1 Cause or allow an animal to stray onto, move over, graze or be left unattended on local government land.
- 7.5.2 Cause or allow an animal to enter, swim, bathe or remain in any waters located on local government land.
- 7.5.3 Lead, herd or exercise an animal, except where the Council has set aside a track or other area for use by or in connection with an animal of that kind and provided that the animal or animals are under effective control.
- 7.6 *Annoyance*
- By making a noise or creating a disturbance do anything likely to offend or unreasonably interfere with any other person:
- 7.6.1 using that land; or
- 7.6.2 occupying nearby premises.
- 7.7 *Aquatic Life*
- Introduce any aquatic life to any waters located on local government land.
- 7.8 *Attachments*
- Attach anything to a tree, plant, equipment, fence, post, structure or fixture on local government land.
- 7.9 *Bees*
- Place or allow to remain any hive of bees on local government land.
- 7.10 *Boats and Mooring*
- Subject to the provisions of the Harbors and Navigation Act 1993:
- 7.10.1 launch or retrieve a boat to or from any waters where the Council has determined that this Clause applies;
- 7.10.2 launch or retrieve a boat from the foreshore without using a boat ramp or thoroughfare constructed or set aside by the Council for that purpose;
- 7.10.3 propel, float or otherwise use a boat on or in any waters;
- 7.10.4 hire out a boat or otherwise use a boat for commercial purposes;
- 7.10.5 moor a boat on or to local government land to which the Council has determined this Clause applies;
- 7.10.6 moor any boat on or to local government land other than in accordance with such time limits and other conditions determined by resolution of the Council and set out in a notice on or in the immediate vicinity of the land to which the time limits or other conditions apply; or
- 7.10.7 obstruct any boat, mooring site or access (either by water or land) to any boat (either floating or sunk).
- 7.11 *Bridge Jumping*
- Jump or dive from a bridge on local government land.

- 7.12 *Buildings*  
Use a building or structure on local government land for a purpose other than its intended purpose.
- 7.13 *Burials and Memorials*
- 7.13.1 Bury, intern or spread:  
(a) the ashes of any human; or  
(b) animal remains.
- 7.13.2 Erect any Memorial.
- 7.14 *Camping and Tents*
- 7.14.1 Erect a tent or other structure of calico, canvas, plastic or similar material as a place of habitation.
- 7.14.2 Camp or sleep overnight except where a person is in a caravan park on local government land, the proprietor of which has been given permission to operate the caravan park on that land.
- 7.15 *Canvassing*  
Convey any advertising, religious or other message to any bystander, passer-by or other person.
- 7.16 *Defacing Property*  
Deface, paint, spray, write, cut names, letters or make marks on any tree, rock, gate, fence, building, sign, bridge or property of the Council.
- 7.17 *Distribute Material*  
Subject to Clause 4.5, place on a vehicle (without the consent of the owner of the vehicle) or give out or distribute any hand bill, book, notice, leaflet, or other printed matter to any bystander, passer-by or other person.
- 7.18 *Donations*  
Ask for or receive or indicate that he or she desires a donation of money or any other thing.
- 7.19 *Entertainment and Busking*
- 7.19.1 Sing, busk or play a recording or use a musical instrument for the apparent purpose of either entertaining others or receiving money.
- 7.19.2 Conduct or hold a concert, festival, show, public gathering, circus, meeting, performance or any other similar activity.
- 7.20 *Equipment*  
Use an item of equipment, facilities or property belonging to the Council if that person is of or over the age indicated by a sign or notice as the age limit for using such equipment, facility or property.
- 7.21 *Fires*  
Subject to the Fire and Emergency Services Act 2005, light a fire except:
- 7.21.1 in a place provided by the Council for that purpose; or
- 7.21.2 in a portable barbeque, as long as the barbeque is used in an area that is clear of flammable material for a distance of at least 4 metres.
- 7.22 *Fireworks*  
Subject to the Explosives (Fireworks) Regulations 2016, ignite or discharge any fireworks.
- 7.23 *Flora and Fauna*  
Subject to the Native Vegetation Act 1991 and the National Parks and Wildlife Act 1972:
- 7.23.1 damage, pick, disturb, interfere with or remove any plant or flower;
- 7.23.2 cause or allow an animal to stand or walk on any flower bed or garden plot;
- 7.23.3 deposit, dig, damage, disturb, interfere with or remove any soil, stone, wood, clay, gravel, pebbles, timber, bark or any part of the land;
- 7.23.4 take, interfere with, tease, harm or disturb any animal, bird or marine creature or the eggs or young of any animal, bird or marine creature;
- 7.23.5 pick, collect, take, interfere with or disturb any fruit, nuts, berries or native seeds;
- 7.23.6 disturb, interfere with or damage any burrow, nest or habitat of any animal or bird;
- 7.23.7 use, possess or have control of any device for the purpose of killing or capturing any animal, bird or aquatic creature; or
- 7.23.8 burn any timber or dead wood.
- 7.24 *Foreshore*  
On local government land comprising the foreshore:
- 7.24.1 drive or propel a vehicle onto or from the foreshore other than by a ramp or thoroughfare constructed or set aside by the Council for that purpose;
- 7.24.2 drive or propel a vehicle on the foreshore except on an area that is constructed or set aside by the Council for that purpose; or
- 7.24.3 allow a vehicle to remain stationary on a boat ramp longer than is necessary to launch or retrieve a boat.
- 7.25 *Games*
- 7.25.1 Participate in, promote or organise any organised competition or sport, as distinct from organised social play.
- 7.25.2 Play or practise any game which involves kicking, hitting or throwing a ball or other object on local government land which may detract from or be likely to detract from another person's lawful use and enjoyment of that land.
- 7.25.3 Play or practise the game of golf on local government land to which the Council has determined by resolution this Clause applies.
- 7.26 *Litter*  
Subject to the Local Nuisance and Litter Control Act 2016:
- 7.26.1 throw, cast, place, deposit or leave any rubbish, dirt or refuse of any kind whatsoever except in a garbage container provided for that purpose; or
- 7.26.2 deposit any soil, clay, stone, gravel, green waste or other putrescible waste or any other matter.
- 7.27 *Model Aircraft, Boats and Cars*  
Fly or operate a model aircraft, boat or model or remote control vehicle in a manner which may cause or be likely to cause injury or discomfort to a person being on, or in the vicinity of, the land or detract from or be likely to detract from another person's lawful use of and enjoyment of the land.
- 7.28 *Overhanging Articles*  
Suspend or hang an article or object from a building, verandah, pergola, post or other structure on local government land where it might present a nuisance or danger to a person using the land or be of an unsightly nature.
- 7.29 *Playing Area*  
Use or occupy a playing area:
- 7.29.1 in such a manner as to damage or be likely to damage the surface of the playing area or infrastructure located at, above or under ground level;
- 7.29.2 in a manner contrary to the purpose for which the playing area was intended to be used or occupied; or
- 7.29.3 contrary to directions of the Council made by resolution and indicated on a sign displayed adjacent to the playing area.

- 7.30 *Posting of Bills*  
Post or allow or cause to be posted any bills, advertisements or other papers or items on a building or structure on local government land or in a public place.
- 7.31 *Preaching*  
Preach, harangue or solicit for religious purposes.
- 7.32 *Ropes*  
Place a buoy, cable, chain, hawser, rope or net in or across any waters.
- 7.33 *Rubbish and Rubbish Dumps*
- 7.33.1 Interfere with, remove or take away rubbish that has been discarded at any rubbish dump on local government land.
- 7.33.2 Remove, disperse or interfere with rubbish, including bottles, newspapers, cans, containers, or packaging that has been discarded in a Council-owned rubbish bin on local government land.
- 7.34 *Swimming*  
Subject to the provisions of the Harbors and Navigation Act 1993, swim in, bathe or enter any waters except:
- 7.34.1 in an area which the Council has determined may be used for such purposes; and
- 7.34.2 in accordance with any conditions that the Council may have determined by resolution apply to such use.
- 7.35 *Trading*  
Sell, buy, offer or display anything for sale, hire or lease.
- 7.36 *Vehicles*
- 7.36.1 Drive or propel a vehicle except on an area or road constructed and set aside by the Council for that purpose.
- 7.36.2 Promote, organise or take part in a race, test or trial of any kind in which vehicles take part, except on an area properly constructed for that purpose.
- 7.36.3 Repair, wash, paint, panel beat or carry out other work to a vehicle, except for running repairs in the case of a breakdown.
- 7.37 *Weddings, Functions and Special Events*
- 7.37.1 Hold, conduct or participate in a marriage ceremony, funeral or special event.
- 7.37.2 Erect a marquee, stage or structure for the purpose of holding or conducting a wedding, funeral or special event.
- 7.37.3 Hold or conduct any filming for a commercial purpose.
8. *Prohibited Activities*  
No person shall on any local government land:
- 8.1 *Animals*
- 8.1.1 Cause or allow any animal to enter, swim, bathe or remain in any waters to the inconvenience, annoyance or danger of any other person bathing or swimming.
- 8.1.2 Cause or allow an animal to damage a flowerbed, garden plot, tree, lawn or like thing or place.
- 8.1.3 Lead, herd or exercise a horse in such manner as to cause a nuisance or endanger the safety of a person.
- 8.2 *Equipment*  
Subject to Clause 7.20, use any item of equipment, facilities or property belonging to the Council other than in the manner and for the purpose for which it was designed, constructed or intended to be used or in such manner as is likely to damage or destroy it.
- 8.3 *Fishing*  
Fish in any waters to which the Council has determined this Clause applies.
- 8.4 *Glass*  
Wilfully break any glass, china or other brittle material.
- 8.5 *Interference with Land*  
Interfere with, alter or damage the land (including a building, structure or fixture located on the land) including:
- 8.5.1 altering the construction or arrangement of the land to permit or facilitate access from an adjacent property;
- 8.5.2 erecting or installing a structure in, on, across, under or over the land;
- 8.5.3 changing or interfering with the construction, arrangement or materials of the land;
- 8.5.4 planting a tree or other vegetation on the land, interfering with the vegetation on the land or removing vegetation from the land; or
- 8.5.5 otherwise use the land in a manner contrary to the purpose for which the land is intended to be used.
- 8.6 *Interference with Permitted use*  
Interrupt, disrupt or interfere with any other person's permitted use of local government land.
- 8.7 *Nuisance*  
Behave in such a manner as to cause discomfort, inconvenience, annoyance or offence to any other person.
- 8.8 *Playing Games*  
Play or practise a game:
- 8.8.1 which is likely to cause damage to the land or anything on it;
- 8.8.2 in any area where a sign indicates that the game is prohibited; or
- 8.8.3 subject to Clause 7.25, in a manner which endangers the safety or interferes with the comfort or safety of any person.
- 8.9 *Solicitation*  
Tout or solicit customers for the parking of vehicles or for any other purpose whatsoever.
- 8.10 *Smoking*  
Subject to the Tobacco Products Regulation Act 1997, smoke, hold or otherwise have control over an ignited tobacco product:
- 8.10.1 in any building;
- 8.10.2 in any children's playground; or
- 8.10.3 on any land to which the Council has determined this Clause applies.
- 8.11 *Throwing Objects*  
Throw, roll, project or discharge a stone, substance or other missile, excluding sport and recreational equipment designed to be used in that way.
- 8.12 *Toilets*  
In any public convenience on local government land:
- 8.12.1 urinate other than in a urinal or pan or defecate other than in a pan set apart for that purpose;
- 8.12.2 deposit anything in a pan, urinal or drain which is likely to cause a blockage;
- 8.12.3 use it for a purpose for which it was not designed or constructed;
- 8.12.4 enter a toilet that is set aside for use of the opposite sex except:
- (a) where a child under the age of eight years is accompanied by an adult, parent or guardian of that sex;
- (b) to provide assistance to a disabled person; or
- (c) in the case of a genuine emergency.

8.13 *Waste*

Subject to the Local Nuisance and Litter Control Act 2016:

- 8.13.1 deposit or leave on local government land:
- (a) anything obnoxious or offensive;
  - (b) any offal, dead animal, dung or filth; or
  - (c) any mineral, mineral waste, industrial waste or bi-products;
- 8.13.2 foul or pollute any waters; or
- 8.13.3 deposit in a receptacle any rubbish emanating from domestic or trade purposes, unless designated by a sign or signs.

## PART 4—ENFORCEMENT

9. *Recovery of Expenses*

If a person breaches this by-law and fails to comply with an order of an authorised person made pursuant to Section 262 (1) of the Act, the Council may recover expenses incurred in carrying out the order under Section 262 (3) of the Act from the person who failed to comply with the order as a debt by an action in a court of competent jurisdiction pursuant to Section 144 (1) of the Act.

10. *Removal of Animals and Objects*

An authorised person may remove an animal or object that is on local government land in breach of this by-law if no person is in charge of, or apparently in charge of, the animal or object.

This by-law was duly made and passed at a meeting of the Council held on 12 December 2016 by an absolute majority of the members for the time being constituting the Council, there being at least two-thirds of the members present.

## BY-LAW MADE UNDER THE LOCAL GOVERNMENT ACT 1999

*Roads By-law 2016*  
*By-law No. 3 of 2016*

A by-law to regulate certain activities on roads in the Council area.

## PART 1—PRELIMINARY

1. *Title*

This by-law may be cited as the Roads By-law 2016.

2. *Objectives*

The objectives of this by-law are to manage and regulate the use of roads in the Council area:

- 2.1 to protect the convenience, comfort and safety of road users and members of the public;
- 2.2 to prevent damage to buildings and structures on roads;
- 2.3 to prevent certain nuisances occurring on roads; and
- 2.4 for the good rule and government of the Council area.

3. *Commencement*

- 3.1 The Council's Roads By-law 2010 is revoked from the day on which this by-law comes into operation.
- 3.2 This by-law comes into operation on 1 July 2017.

4. *Application*

- 4.1 The Council's Permits and Penalties By-law 2016 operates in respect of:
  - 4.1.1 permissions required by or given under this by-law; and
  - 4.1.2 penalties for breach of this by-law.
- 4.2 Subject to Clause 4.3 and 4.4, this by-law applies throughout the Council area.
- 4.3 This by-law does not apply to a police officer, emergency worker, Council officer or employee acting in the course and within the scope of that person's normal duties, or to a contractor while performing work for the

Council and while acting under the supervision of a Council officer.

- 4.4 Clause 6.6 of this by-law does not apply to electoral matter authorised by a candidate and which is related to:

4.4.1 a Commonwealth or State election and occurs during the period commencing on the issue of the writ or writs for the election and ending at the close of polls on polling day; or

4.4.2 an election under the Act or the Local Government (Elections) Act 1999 and occurs during the period commencing four weeks immediately before the date that has been set (either by or under either Act) for polling day and ending at the close of voting on polling day; or

4.4.3 occurs during the course of and for the purpose of a referendum or poll.

5. *Interpretation*

- 5.1 In this by-law, unless the contrary intention appears:

5.1.1 *Act* means the Local Government Act 1999;

5.1.2 *animal* includes birds, insects and poultry but does not include a dog;

5.1.3 *camp* includes setting up a camp, or causing a tent, caravan or motor home to remain on the land for the purpose of staying overnight, whether or not any person is in attendance or sleeps on the land;

5.1.4 *Council* means the Rural City of Murray Bridge;

5.1.5 *effective control* means a person exercising effective control of an animal either:

(a) by means of a physical restraint; or

(b) by command, the animal being in close proximity to the person and the person being able to see the animal at all times;

5.1.6 *electoral matter* has the same meaning as in the Electoral Act 1995, provided that such electoral matter is not capable of causing physical damage or injury to a person within its immediate vicinity;

5.1.7 *emergency worker* has the same meaning as in the Road Traffic (Road Rules—Ancillary and Miscellaneous Provisions) Regulations 2014; and

5.1.8 *vehicle* has the same meaning as in the Road Traffic Act 1961.

- 5.2 This by-law is to be interpreted as being subject to the Act, other Acts and the general law of South Australia.

## PART 2—USE OF ROADS

6. *Activities Requiring Permission*

No person shall without the permission of the Council on any road:

6.1 *Amplification*

Use an amplifier or other device whether mechanical or electrical for the purpose of broadcasting announcements or advertisements.

6.2 *Animals*

6.2.1 Cause or allow an animal to stray onto, move over, or graze on a road except where the Council has set aside a track or other area for use by or in connection with an animal of that kind and provided the animal or animals are under effective control.

6.2.2 Lead, herd or exercise an animal in such a manner as to cause a nuisance or endanger the safety of a person.

### 6.3 *Camping and Tents*

6.3.1 Erect a tent or other structure of calico, canvas, plastic or other similar material as a place of habitation.

6.3.2 Camp or sleep overnight.

### 6.4 *Donations*

Ask for or receive or indicate a desire for a donation of money or any other thing, or otherwise solicit for religious or charitable purposes.

### 6.5 *Obstructions*

Erect, install or place or cause to be erected, installed or placed any structure, object or material of any kind so as to obstruct a road or footway, water channel, or watercourse in a road.

### 6.6 *Posting of Bills*

Subject to the Local Nuisance and Litter Control Act 2016, post or allow or cause to be posted any bills, advertisements, or other papers or items on a building or structure on a road.

### 6.7 *Preaching*

Preach, harangue or solicit for religious purposes.

### 6.8 *Public Exhibitions and Displays*

6.8.1 Sing, busk, play a recording or use a musical instrument, or perform similar activities.

6.8.2 Conduct or hold a concert, festival, show, circus, performance or a similar activity.

6.8.3 Erect a stage or structure for the purpose of conducting or holding a concert, festival, show, circus, performance or a similar activity.

6.8.4 Cause any public exhibitions or displays.

### 6.9 *Vehicles*

Repair, wash, paint, panel beat or perform other work of a similar nature to a vehicle, except for running repairs in the case of a vehicle breakdown.

## PART 3—ENFORCEMENT

### 7. *Recovery of Expenses*

If a person breaches this by-law and does not comply with an order made against them by an authorised person pursuant to Section 262 (1) of the Act, the Council may recover expenses incurred in carrying out the order under Section 262 (3) of the Act from the person who failed to comply with the order as a debt by an action in a court of competent jurisdiction pursuant to Section 144 (1) of the Act.

### 8. *Removal of Animals and Objects*

An authorised person may remove an animal or object that is on a road in breach of a by-law if no person is in charge, or apparently in charge, of the animal or object.

This by-law was duly made and passed at a meeting of the Council held on 12 December 2016 by an absolute majority of the members for the time being constituting the Council, there being at least two-thirds of the members present.

## RURAL CITY OF MURRAY BRIDGE

### BY-LAW MADE UNDER THE LOCAL GOVERNMENT ACT 1999

#### *Moveable Signs By-law 2016*

#### *By-law No. 4 of 2016*

A by-law to regulate the construction and placement of moveable signs on roads.

## PART 1—PRELIMINARY

### 1. *Title*

This by-law may be cited as the Moveable Signs By-law 2016.

### 2. *Objectives*

The objectives of this by-law are to set standards for moveable signs on roads:

2.1 to protect the comfort and safety of road users and members of the public;

2.2 to enhance the amenity of roads and surrounding parts of the Council area;

2.3 to prevent nuisances occurring on roads;

2.4 to prevent unreasonable interference with the use of a road; and

2.5 for the good rule and government of the Council area.

### 3. *Commencement*

3.1 The Council's Moveable Signs By-law 2010 is revoked from the day on which this by-law comes into operation.

3.2 This by-law comes into operation on 1 July 2017.

### 4. *Application*

4.1 The Permits and Penalties By-law 2016 operates in respect of:

4.1.1 permissions required by or given under this by-law; and

4.1.2 penalties for breach of this by-law.

4.2 This by-law applies throughout the Council area.

### 5. *Interpretation*

5.1 In this by-law, unless the contrary intention appears:

5.1.1 *Act* means the Local Government Act 1999;

5.1.2 *arterial road* means a main road that is included in the following list:

(a) Adelaide Road, Murray Bridge;

(b) Bridge Street, Murray Bridge;

(c) Princes Highway, Murray Bridge East;

(d) Swanport Road, Murray Bridge;

(e) Mannum Road, Murray Bridge to Council boundary;

(f) Maurice Road, Murray Bridge, Mulgundawah Road to Cypress Terrace;

(g) Hindmarsh Road, Murray Bridge;

(h) Cypress Terrace, Murray Bridge;

(i) Green Street, Myponga;

(j) Drummond Street, Jervois;

(k) Rayson Street, Jervois;

(l) Jervois/Langhorne Creek Road, Wellington, from Shankland Road to Richards Street; and

(m) East Terrace, Callington, from Cemetery to Jaensch Roads;

5.1.3 *banner* means a sign that is made from non-rigid and lightweight material which is mounted to a building or other structure by its ends or corners;

5.1.4 *business premises* means premises from which a business is conducted;

5.1.5 *Council* means the Rural City of Murray Bridge;

5.1.6 *footpath area* means:

(a) that part of a road between the property boundary of the road and the edge of the carriageway on the same side as that boundary;

(b) a footway, lane or other place made or constructed for the use of pedestrians and not for the use of vehicles;

5.1.7 *tear drop sign* means a sign in the style of a tear drop sign or feather sign;

5.1.8 *vehicle* has the same meaning as in the Road Traffic Act 1961.

5.2 This by-law is to be interpreted as being subject to the Act, other Acts and the general law of South Australia.

## PART 2—MOVEABLE SIGNS

### 6. *Construction and Design*

A moveable sign placed on a footpath area must:

- 6.1 be of a kind known as an 'A' frame or sandwich board sign, an inverted 'T' sign, or a flat sign, a tear drop sign or, with the permission of the Council, a sign of some other kind;
- 6.2 be designed, constructed and maintained in good quality and condition;
- 6.3 be of strong construction and sufficiently stable or securely fixed so as to keep its position in adverse weather conditions;
- 6.4 have no sharp or jagged edges or corners;
- 6.5 not be unsightly or offensive in appearance or content;
- 6.6 be constructed of timber, cloth, metal, plastic or plastic coated cardboard, or a mixture of such materials;
- 6.7 not exceed 900 mm in height, 600 mm in width and 600 mm in depth where the speed limit that applies to the road adjacent to the footpath area upon which the sign is placed does not exceed 60 km per hour;
- 6.8 not exceed 1200 mm in height, 900 mm in width and 900 mm in depth where the speed limit that applies to the road adjacent to the footpath area upon which the sign is placed exceeds 60 km per hour;
- 6.9 in the case of an 'A' frame or sandwich board sign:
  - 6.9.1 be hinged or joined at the top;
  - 6.9.2 be of such construction that its sides are securely fixed or locked in position when erected; and
  - 6.9.3 not have a base area in excess of 0.6 square metres; and
- 6.10 in the case of an inverted 'T' sign, not contain struts or members that run between the display area and the base of the sign.

#### 7. Placement

- 7.1 Subject to this Clause 7, a moveable sign may be placed:
  - 7.1.1 on a footpath that is at least 2.5 metres wide;
  - 7.1.2 at least 0.6 metres from:
    - (a) where the road has a kerb, the kerb;
    - (b) where the road has no kerb but has a shoulder, the shoulder;
    - (c) where the road has neither a kerb nor a shoulder, the edge of the carriageway.
- 7.2 A moveable sign must not be placed:
  - 7.2.1 on the sealed part of a footpath, if there is an unsealed part on which the sign can be placed in accordance with this by-law;
  - 7.2.2 on a landscaped area, other than landscaping that comprises only lawn;
  - 7.2.3 within 6 metres of an intersection of two or more roads;
  - 7.2.4 on a footpath area with a minimum height clearance from a structure above it of less than 2 metres;
  - 7.2.5 closer than 2 metres from another fixed object, tree, bush plant or structure other than an entrance to premises;
  - 7.2.6 on a designated parking area or within 1 metre of an entrance to premises;
  - 7.2.7 so as to interfere with the reasonable movement of persons or vehicles using the footpath or road in the vicinity of where the moveable sign is placed;
  - 7.2.8 in such a position or in such circumstances that the safety of a user of the footpath area or road is at risk; or
  - 7.2.9 so as to obstruct or impede a vehicle door when opened, provided that the vehicle is parked lawfully on a carriageway.

#### 8. Appearance

A moveable sign placed on the footpath area of a road must, in the opinion of an authorised person:

- 8.1 be painted or otherwise detailed in a competent and professional manner;
- 8.2 be attractive, legible and simply worded to convey a precise message;
- 8.3 be of such design and contain such colours which are compatible with the architectural design of the premises adjacent to the sign and which relate well to the town scope and overall amenity of the locality in which it is situated;
- 8.4 contain combinations of colour and typographical styles which blend in with and reinforce the heritage qualities of the locality and the buildings where it is situated;
- 8.5 not have balloons, flags, streamers or other things attached to it; and
- 8.6 not rotate or contain flashing parts.

#### 9. Banners

A person must not erect or display a banner on a building or structure on a road without the Council's permission.

#### 10. Restrictions

- 10.1 A moveable sign must:
  - 10.1.1 be limited to one moveable sign per business premises unless the business is located on a road that is not an arterial road, in which case two signs can be placed, one on each of:
    - (a) the footpath of the arterial road closest to the business as a directional sign; and
    - (b) the footpath in front of the business;
  - 10.1.2 not be displayed on or attached to or adjacent to a vehicle that is parked on local government land (including roads) primarily for the purpose of advertising or offering for sale a product (including the vehicle) or business to which the sign relates;
  - 10.1.3 subject to Clause 10.1.1, only display material which advertises a business being conducted on premises adjacent to the moveable sign or goods and services available from that business;
  - 10.1.4 only be displayed when the business premises to which it relates is open to the public;
  - 10.1.5 not be displayed during the hours of darkness unless clearly lit; and
  - 10.1.6 be securely fixed in a position that it cannot be blown over or swept away.
- 10.2 Notwithstanding compliance with the provisions of this by-law, if in the opinion of the Council a footpath area is unsafe for a moveable sign to be displayed either permanently or for a period of time, the Council may prohibit or restrict the display of a moveable sign on such conditions as the Council thinks fit.

#### 11. Exemptions

- 11.1 Clauses 8, 10.1.1 and 10.1.3 of this by-law do not apply to a moveable sign which:
  - 11.1.1 advertises a garage sale taking place from residential premises; or
  - 11.1.2 is a directional sign to an event run by a community organisation or charitable body.
- 11.2 Clause 7 of this by-law does not apply to a moveable sign which advertises a garage sale taking place from residential premises.
- 11.3 Clauses 10.1.1 and 10.1.3 of this by-law do not apply to a flat sign which only contains a newspaper headline and the name of a newspaper or magazine.
- 11.4 A requirement of this by-law will not apply where the Council has granted permission for the moveable sign to be displayed contrary to that requirement.
- 11.5 This by-law will not apply to a moveable sign which is:
  - 11.5.1 placed on a road pursuant to an authorisation under the Act or another Act;
  - 11.5.2 designed to direct people to the open inspection of any land or building that is available for purchase or lease;

- 11.5.3 related to a State or Commonwealth election and is displayed during the period commencing on the issue of writ or writs for the election and ending at the close of polls on polling day; or
- 11.5.4 related to an election held under the Act or the Local Government Elections Act 1999 and is displayed during the period commencing four weeks immediately before the date that has been set (either by or under either Act) for polling day and ending at the close of voting on polling day.

#### 12. Removal of Moveable Signs

The owner or other person responsible for a moveable sign must remove or relocate the moveable sign at the request of an authorised person:

- 12.1 if, in the opinion of the authorised person, and notwithstanding compliance with this by-law, there is any hazard or obstruction or there is likely to be a hazard or obstruction arising out of the location of the moveable sign; or
- 12.2 for the purpose of special events, parades, road works or in any other circumstances which, in the opinion of the authorised person, require relocation or removal of the moveable sign to protect public safety or to protect or enhance the amenity of a particular locality.

#### PART 3—ENFORCEMENT

#### 13. Recovery of Expenses

If a person breaches this by-law and does not comply with an order made against them by an authorised person pursuant to Section 262 (1) of the Act, the Council may recover expenses incurred in carrying out the order under Section 262 (3) of the Act from the person who failed to comply with the order as a debt by an action in a court of competent jurisdiction pursuant to Section 144 (1) of the Act.

#### BY-LAW MADE UNDER THE LOCAL GOVERNMENT ACT 1999

#### *Dogs By-law 2016*

#### *By-law No. 5 of 2016*

A by-law for the management and control of dogs in the Council area.

#### PART 1—PRELIMINARY

##### 1. Title

This by-law may be cited as the Dogs By-law 2016.

##### 2. Objectives

The objectives of this by-law are to control and manage dogs in the Council area:

- 2.1 to reduce the incidence of environmental nuisance caused by dogs;
- 2.2 to promote responsible dog ownership;
- 2.3 to protect the convenience, comfort and safety of members of the public; and
- 2.4 for the good rule and government of the Council area.

##### 3. Commencement

- 3.1 The Council's Dogs By-law 2010 is revoked from the day on which this by-law comes into operation.
- 3.2 This by-law comes into operation on 1 July 2017.

##### 4. Application

- 4.1 The Council's Permits and Penalties By-law 2016 operates in respect of:
- 4.1.1 permissions required by or given under this by-law; and
- 4.1.2 penalties for breach of this by-law.

- 4.2 Subject to Clause 4.3, this by-law applies throughout the Council area.
- 4.3 Clauses 8.2 and 9.2 of this by-law only apply in such part or parts of the Council area as the Council may determine by resolution in accordance with Section 246 (3) (e) of the Act.

#### 5. Interpretation

In this by-law, unless the contrary intention appears:

- 5.1 *Act* means the Local Government Act 1999;
- 5.2 *approved kennel establishment* means a building, structure or area approved by a relevant authority, pursuant to the Development Act 1993 for the keeping of dogs on a temporary or permanent basis;
- 5.3 *assistance dog* means dog trained and used for the purpose of assisting a person who is wholly or partially disabled and includes a dog undergoing training of a kind approved by the Dog and Cat Management Board for the purposes of this definition;
- 5.4 *children's playground* means an enclosed area in which there is equipment or other installed devices for the purpose of children's play (or within 3 metres of such devices if there is no enclosed area);
- 5.5 *Council* means the Rural City of Murray Bridge;
- 5.6 *detached dwelling*, *row dwelling* and *semi-detached dwelling* have the same meanings as in the Development Act 1993;
- 5.7 *dog* has the same meaning as in the Dog and Cat Management Act 1995;
- 5.8 *effective control* means a person exercising effective control of a dog either:
- 5.8.1 by means of a physical restraint; or
- 5.8.2 by command, the dog being in close proximity to the person and the person being able to see the dog at all times;
- 5.9 *keep* includes the provision of food or shelter;
- 5.10 *premises* includes land, whether used or occupied for domestic or non-domestic purposes, except an approved kennel establishment;
- 5.11 *small dwelling* means a self-contained residence that is:
- 5.11.1 a residential flat;
- 5.11.2 a strata unit;
- 5.11.3 on an allotment less than 400 square metres in area; or
- 5.11.4 without a secure yard of at least 100 square metres in area;
- 5.12 *working livestock dog* means a dog:
- 5.12.1 usually kept, proposed to be kept or worked on rural land by a person who is:
- (a) a primary producer; or
- (b) engaged or employed by a primary producer; and
- 5.12.2 kept primarily for the purpose of herding, droving, protecting, tending or working stock, or training for herding, droving, protecting, tending or working stock.

#### PART 2—LIMITS ON DOG NUMBERS

##### 6. Limits on Dog Numbers in Private Premises

- 6.1 Subject to Clauses 6.3 and 6.4, a person must not, without the Council's permission keep:
- 6.1.1 in a township, more than one dog in a small dwelling;
- 6.1.2 in a township, more than two dogs in premises other than a small dwelling; or
- 6.1.3 in premises outside of a township, more than three dogs (other than working livestock dogs).
- 6.2 For the purposes of Clause 6.1, 'dog' means a dog that is three months of age or older or a dog that has lost its juvenile teeth.



6.3 Clause 6.1 does not apply to:

6.3.1 any approved kennel establishment provided it is operating in accordance with all required approvals and consents; or

6.3.2 any business involving dogs provided that the business is registered in accordance with the Dog and Cat Management Act 1995.

6.4 No dog is to be kept on any premises where, in the opinion of an authorised person, there is no secure or appropriate area where a dog may be effectively confined.

#### PART 3—DOG CONTROLS

##### 7. Dog Exercise Areas

7.1 Subject to Clauses 8 and 9 of this by-law, a person may for the purpose of exercising a dog enter:

7.1.1 a park in the Council area; or

7.1.2 any other area of local government land designated by the Council as a dog exercise area.

7.2 Where a person enters a park or other area of local government land designated as a dog exercise area for the purpose of exercising a dog, he or she shall ensure that the dog is under his or her effective control at all times.

##### 8. Dog on Leash Areas

A person must not, without the Council's permission, allow a dog under that person's control, charge or authority (except an accredited assistance dog that is required to remain off-lead in order to fulfil its functions) to be or remain:

8.1 on any park or reserve during times when organised sport is being played; or

8.2 on any other local government land or public place to which the Council has determined that this Clause applies,

unless the dog is secured by a strong leash not exceeding 2 metres in length which is either tethered securely to a fixed object capable of securing the dog or held by a person capable of controlling the dog and preventing it from being a nuisance or a danger to other persons.

##### 9. Dog Prohibited Areas

A person must not allow a dog under that person's control, charge or authority (except an accredited assistance dog) to enter or remain:

9.1 on any children's playground on local government land; or

9.2 on any other local government land or public place to which the Council has determined that this Clause applies.

##### 10. Dog Faeces

No person is to allow a dog under that person's control, charge or authority to be in a public place or on local government land unless that person has in their possession a bag or other suitable

container for the collection and lawful disposal of any faeces that the dog may deposit for the purpose of complying with their obligation under Section 45 A (6) of the Dog and Cat Management Act 1995.

#### PART 4—ENFORCEMENT

##### 11. Recovery of Expenses

If a person breaches this by-law and does not comply with an order made against them by an authorised person pursuant to Section 262 (1) of the Act, the Council may recover expenses incurred in carrying out the order under Section 262 (3) of the Act from the person who failed to comply with the order as a debt by an action in a court of competent jurisdiction pursuant to Section 144 (1) of the Act.
